



Executive Order 13985

"The Federal Government should pursue a comprehensive approach to advancing equity for all, including people of color and others who have been historically underserved, marginalized, and adversely affected by persistent poverty and inequality."



NCPC's Approach

- **Identify** impacted stakeholders, communities, or groups.
- Ascertain whether NCPC's work has historically overlooked opportunities for equitable treatment
- **Update** policies, decisions, practices, or procedures to ensure equitable treatment
- Undertake proactive and ongoing steps to evaluate outcomes of newly implemented or revised policies or practices


BEYOND GRANITE Pilot Program



- Broaden subject matter representation and elevate underrepresented stories
- Expand opportunities for participation in commemoration
- Inform updates to plans and guidance used for NCPC's commemoration initiative, including the Memorials and Museums Master Plan (2M Plan)


Comprehensive Plan for the National Capital Federal Elements **Washington Monument**

- Update the Comprehensive Plan's Introduction Chapter
- Develop an equity crosswalk of existing policies that focus on advancing equity
- Incorporate equity considerations into future element updates
- Develop robust public engagement strategy that reaches out to underserved communities



- Incorporate equity-related questions to determine how proposed projects might create or reduce equity disparities
- Engage with federal agencies to help them consider equity early in the planning process of capital investments

Equity Emphasis Areas



- Indicates the proximity of Equity
 Emphasis Areas to federal facilities
- Helps planners better understand regional conditions

Review of Master Plans and Significant Projects



- Develop equity-related resources for applicants
- Amend the Submission Guidelines to include equity screening questions
- Amend the Submission Guidelines to encourage applicants to conduct public outreach earlier

Public Engagement for Commission Meetings



- Meet with individuals and organizations from underserved communities
- Harness technology for more equitable public participation
- Expand the agency's distribution list
- Review and update public meeting materials and outreach tools

NCPC's 2024 Centennial



- Examine the legacy of planning and development in the region, and specifically NCPC's role
- Explore where planning efforts resulted in inequitable outcomes and how that shapes communities today

- Coordinate with agency's efforts to promote DEIA in the workforce
