## **TPB Work Program Responds to New Federal Regulations**

The Transportation Planning Board is scheduled on March 21 to approve a work program that reflects new federal requirements, including activities related to public participation, freight and safety planning, and a revamped congestion management process.

Federal law requires metropolitan planning organizations (MPOs) like the TPB to approve a new Unified Planning Work Program (UPWP) every year. The new work program was designed to ensure compliance with federal metropolitan planning regulations, published on February 14. Those regulations provide for the implementation of planning provisions in the 2005 federal surface transportation act, known as SAFETEA-LU.

### Focusing on Bus Safety



Mr. Jack Requa, Metro's Chief Operating Officer for Metrobus, spoke to the TPB on February 21 about steps the agency is taking to prevent future bus accidents, especially those involving pedestrians.

The draft fiscal year 2008 budget presented to the TPB at its February 21 meeting was \$11,749,000, the same as in FY2007. The FY2008 UPWP will begin July 1, 2007.

have been updated since 1993. SAFETEA-LU and the new regulations have broadened the things we need to do as an MPO."

The new federal regulations require the TPB to develop a Participation Plan and ensure the usage of "visualization" techniques and consultation procedures. The regulations also require enhanced freight planning, human services coordination and safety planning activities.

The TPB is funding a number of other new activities not required by federal law, including the new Transportation/Land-Use Connections (TLC) program, new supplemental traffic counts, and new regional transit planning activities, including the new Regional Bus Subcommittee.

**Background:** Commuter Connections includes a number of programs that assist and encourage people in the region to use alternatives to the single-occupant automobile. The CCWP budget for FY 2008 is \$4.99 million, compared to \$5.95 million in the current year. New or recent

additions to the CCWP include the Live Near Your Work campaign, new Transportation Demand Management software, and additional monitoring and evaluation activities. The TPB is scheduled to approve the CCWP on March 21. The draft CCWP is available at www.mwcog.org/transportation/tpb/. See Item 13 under the meeting of February 21.

• Approval of a letter to the Metropolitan Washington Air Quality Committee (MWAQC) concerning issues related to the region's 8-hour ozone State Implementation Plan (SIP).

Background: Whenever the TPB updates or amends the region's transportation plans or programs, the board must also approve an air quality "conformity determination" showing that forecasted emissions will conform to mobile emissions budgets (ceilings on transportation-related emissions levels) that are established in the regional air quality plan, known as the SIP. On March 15, MWAQC is planning to release a new SIP that will show how the region will meet new, more stringent, federal standards (the 8-hour standard) for ground-level ozone. The TPB has worked closely with MWAQC in establishing mobile emissions budgets for the new SIP.

# Citizens Committee Makes Recommendations on Scenario Study

At the TPB meeting of February 21, Emmet Tydings, 2006 CAC chair, presented a series of recommendations on the future of the TPB's land use and transportation scenario study, known as the Regional Mobility and Accessibility Study. Following the presentation, TPB members asked staff to prepare an action plan for addressing the recommendations. The full text of the recommendations can be found at www.mwcog.org/transportation/committee/cac.

#### **GOALS**

- The scenario study should be used as a tool to influence project selection and local land use decisions.
- The scenario study should be used to raise awareness with decision-makers and citizens about regional challenges.
- The scenario study should effectively use public outreach to inform future scenario planning activities, including the development of regional priorities and identification of implementation strategies.

#### RECOMMENDATIONS

- 1. Make available the study findings, including the brochure and "What If" presentation, to elected officials and local planning efforts.
- 2. Support and expand the Transportation/Land-Use Connections (TLC) program.
- 3. Expand outreach to educate the public and raise awareness of regional challenges.
- 4. Establish a process for gathering public input and feeding it back to the TPB for the development of refined, new or composite scenarios.
- 5. Provide public-friendly information on the TPB's variably priced lane scenario as quickly as possible.
- 6. Move forward with developing and refining scenarios.
- 7. Use the RMAS scenarios to develop a plan of regional priorities.
- 8. Develop useful analysis of existing scenarios ("drill down") to provide more detail on which actions could be most effective.
- 9. Analyze a scenario or scenarios that assume the conversion of existing general purpose lanes to variably priced lanes.
- 10. The TPB should establish a working group to look at future phases of and steps to implement the study.
- Approval of new Citizens Advisory Committee (CAC) members for the District of Columbia: Grace Malakoff, Robin Marlin, Merle Van Horne, Vera Abbot (alternate) and Joseph Bowser (alternate).
- Update on the Washington Metropolitan Area Transportation Operations Coordination (MATOC) program. Staff reported that they were proceeding with the finalization of the interagency agreements needed to implement the MATOC program.
