The analysis took a regional approach to future growth and guided it to walkable Activity Centers with excess transit capacity.

Mr. Schwartz will describe the Coalition for Smarter Growth's work to transform the built environment in suburban commercial corridors. Creating mixed-use, mixed-income communities in an environment that provides and promotes safe walking, bicycling and transit use, offers important health benefits. These environments increase walking and bicycling, reduce deaths and serious injuries, and can improve access to parks and recreation. Ensuring the preservation and inclusion of affordable housing in the redevelopment of commercial corridors can also address a significant stress inducer for many families — the lack of a secure place to call home.
