Montgomery County's Smart Growth Initiative, is a multi-faceted project to deploy programmed resources to implement master plans, to support economic development and affordable transit-oriented development at Shady Grove metro station, and at planned Corridor City Transitway stops. It has relocated industrial uses at the terminus of the Redline and used creative tools to minimize land costs such as density swapping, bonus densities for affordable housing, and use of agricultural development rights.

Fairfax County has studied how to convert vacant and obsolete buildings both inside and outside of Activity Centers. Ms. Van Dam will share recommendations from that effort.
