Regional Roadway Safety Program

- Third round
- Established and funded by the TPB via Resolution R3-2021 adopted July 2021
- Promotes TPB roadway safety priorities
- Program Funding (FY 2023)
 - Core UPWP: \$150,000
 - Maryland Technical Assistance: \$35,000
 - Virginia Technical Assistance: \$35,000
 - District of Columbia Technical Assistance: \$30,000
 - **Total Program Funding: \$250,000**



Solicitation

- Application solicitation between January 18 – March 18, 2022
 - Optional abstracts were due February 11
- 10 applications were received totaling \$640,000 in funding requests
 - Four applications from Maryland jurisdictions and six applications from Virginia jurisdictions
 - Nine were within or adjacent to Equity Emphasis Areas
 - Three were for Roadway Safety Audits
 - Two were primarily focuses on analysis of safety data



Selection

- Selection Panel
 - TPB staff + safety officials from DDOT, MDOT, and VDOT
 - Individual Evaluations



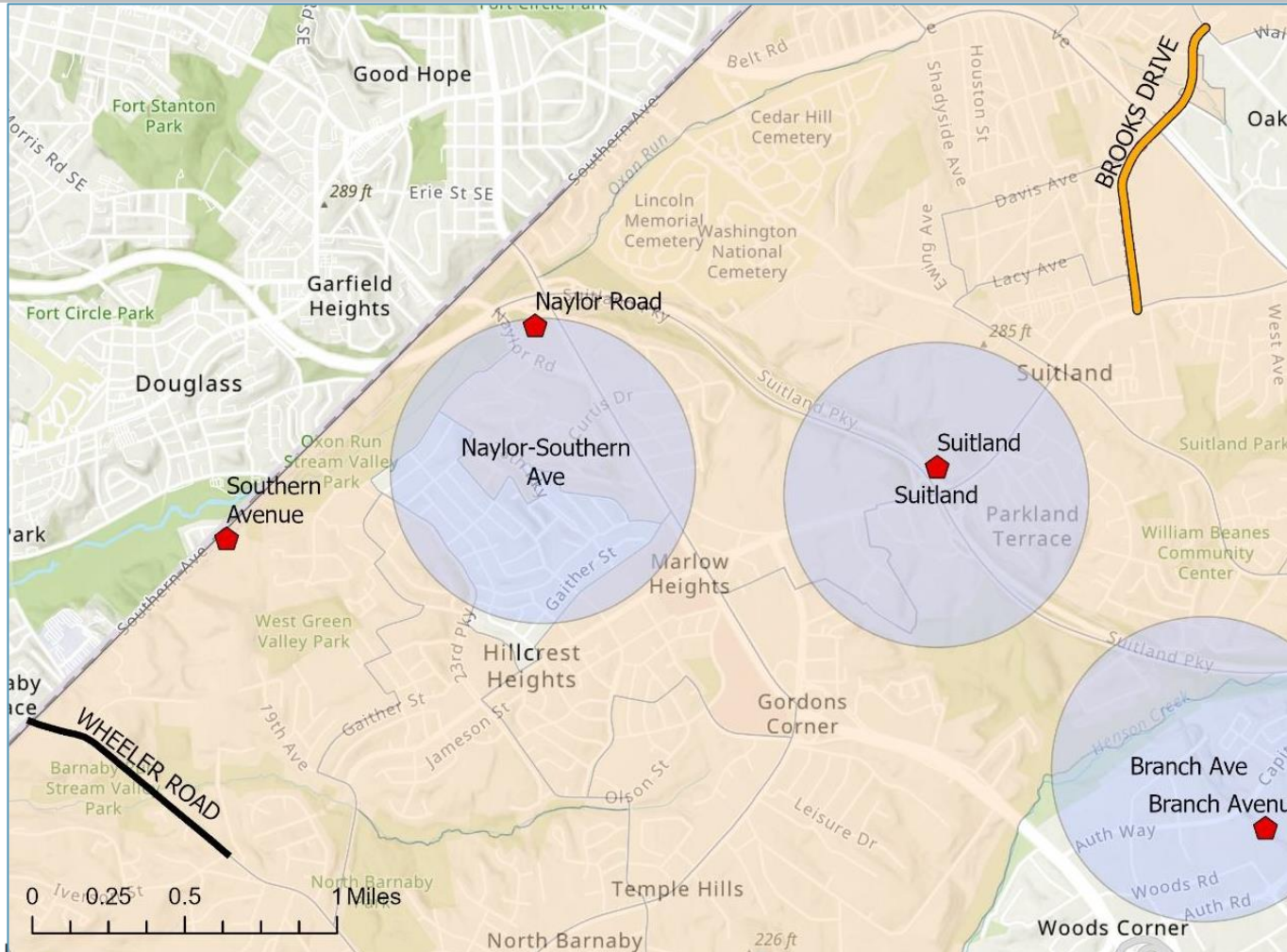

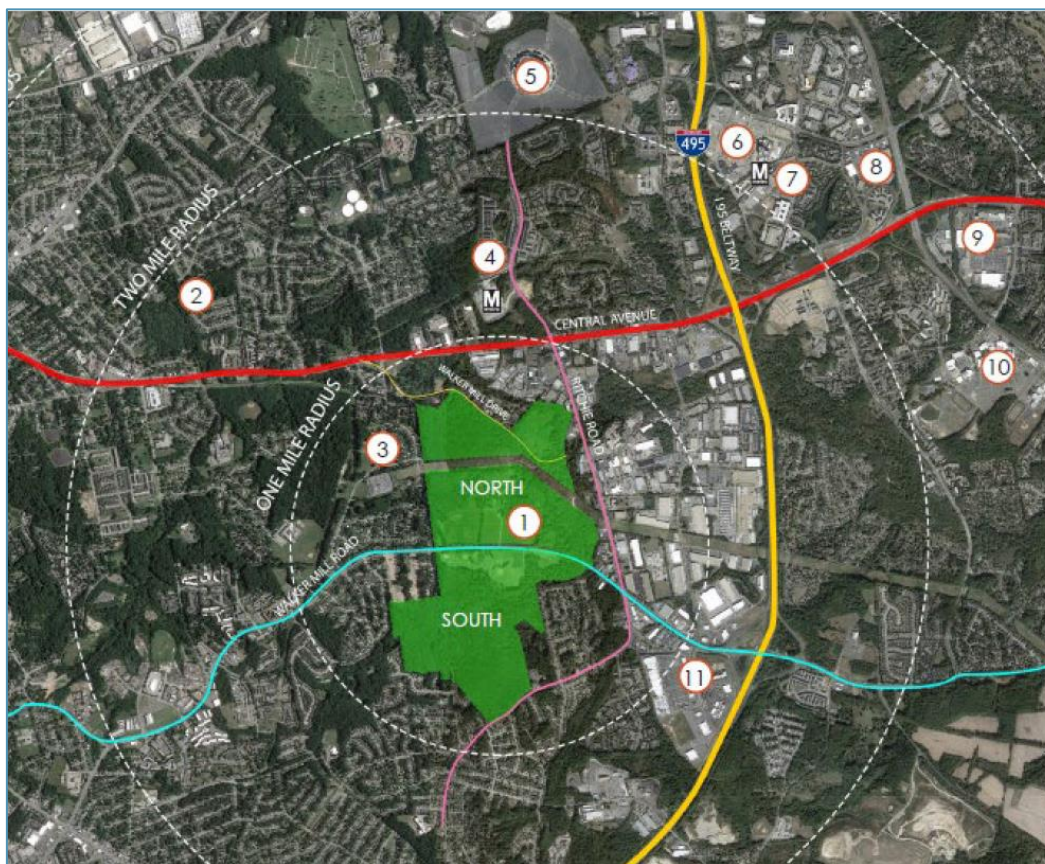


Roadway Safety Audits for Wheeler Road & Brooks Drive (Prince George's County: \$60,000)

(Maryland-National Capital Park and Planning Commission: \$60,000)



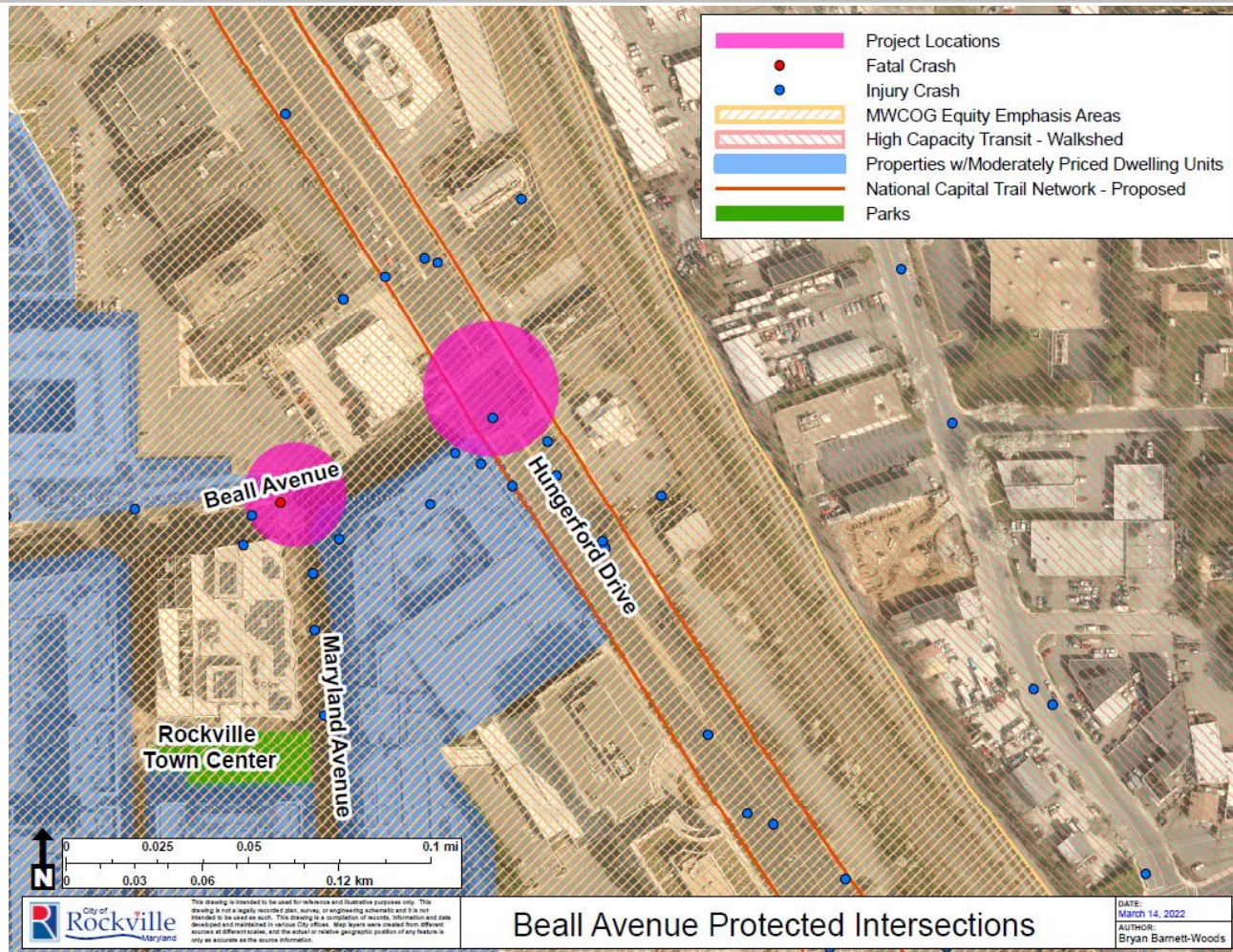
