
Mission & Vision



COVID-19 Response Community Feedback



Collecting feedback from food assistance providers on what a more resilient and efficient local food system could look like.

 Responses from a survey and three listening sessions with food assistance providers will inform recommendations for the Food Security Task Force

Food Access Survey

- Gathered feedback from over 2,500 residents on food access challenges during the pandemic with the goal of repeating in future years for longitudinal study
- Offered in five languages
- Compiling results summaries to inform the work of policymakers, agencies, and community partners
- Exploring collaboration opportunities with CAFB to align future surveys


