

TPB Technical Committee Meeting Highlights

December 3, 2004

The Technical Committee met on Friday, December 3 at COG. Three items were reviewed for inclusion on the TPB agenda on December 15.

- TPB agenda Item 9

The Committee was briefed on the draft results of the 8-hour conformity assessment of the 2004 CLRP and FY 2005-2010 TIP. The Committee recommended that these results be released for public comment at the Citizens Advisory Committee meeting on December 9, 2004.

- TPB agenda Item 10

The Committee was briefed on the draft solicitation document and schedule for the air quality conformity assessment for the 2005 CLRP and FY 2006-2011 TIP. The Committee recommended that the release of the draft solicitation document for next year's CLRP and TIP be changed to a month earlier. This would call for the draft solicitation document to be released in November and the final document be approved by the TPB in December.

- TPB agenda Item 11

The Committee was briefed on the 2003 State of the Commute survey results and on the impacts of Commuter Connections services such as mass marketing and employer outreach.

Three items were presented for information and discussion:

- Staff briefed the Committee on the use of traffic volume estimates in travel demand modeling and transportation planning.
- The Committee was briefed on recently completed and current activities in the travel demand model development program.
- The Committee received an update on the 2000 Census planning package (CTPP) data on worker origin and destination information. A briefing on worker flow patterns for the region is scheduled for a future meeting.
