## **INTRODUCTION**

This directory lists ridesharing, bus and rail services, telework centers, park-and-ride information, and other transportation services, facilities and organizations for the metropolitan Washington and Baltimore regions. Currently, the COMMUTER CONNECTIONS Commuter Operations Center unites into a computer network, the ridesharing programs operated by: COG/TPB, Army National Guard Readiness Center (ARNG), Baltimore City, Baltimore Metropolitan Council, Bethesda Transportation Solutions, City of Alexandria, Dulles Area Transportation Association (DATA), Food and Drug Administration (FDA), Fairfax County, Frederick County (MD), Harford County, Howard County, Loudoun County, Maryland Transit Administration, Montgomery County, National Institutes of Health (NIH), North Bethesda Transportation Center, Northern Neck Planning District Commission, Northern Shenandoah Valley Regional Commission, Potomac and Rappahannock Regional Commission, Prince George's County, Rappahannock Area Development Commission, Rappahannock-Rapidan Regional Commission, Anne Arundel County, the Tri-County Council for Southern Maryland and the Washington Headquarters Services.

The agencies in this network share resources and a single common database of applicants for the purpose of providing the best services to commuters. COMMUTER CONNECTIONS is funded through grants from the District Department of Transportation, the Maryland Department of Transportation, the Virginia Department of Transportation, and the Federal Highway Administration of the U.S. Department of Transportation.

Pool Rewards is a special incentive program available through Commuter Connections designed to encourage current drive-alone commuters to start ridesharing in the Washington Metropolitan region.

Eligible carpools can earn \$2 per day (\$1 each way) for each day you carpool to work over a consecutive 90-day period as assigned by Commuter Connections. The maximum incentive for the 90-day trial period is \$130.00. In exchange, the commuter must go online and log information about their new commute and complete a survey about their experience.

Pool Rewards for Vanpools offers a \$200 monthly subsidy to vanpools that qualify. Qualifications are as follows:

1. Vanpools must have an origin in Maryland, West Virginia, Pennsylvania, New Jersey, or the District of Columbia
2. Are newly-forming vanpools. Newly-forming vanpools are defined as vanpools that have not previously been in operation within 30 days prior to the submission of the Pool Rewards for Vanpools application.
3. Are registered with Commuter Connections.
4. Have a 7 to 15 passenger capacity (including the driver).
5. Submit an application for the program through our qualified vanpool provider, Commute with Enterprise.
