Applications Received

- Staff accepted applications from November 12 to December 17.
- 41 completed applications were received.
- Residents of 15 TPB member jurisdictions submitted applications.
- 29 of those applications have not previously served on the CAC.
- 15 applications graduated from the Community Leadership Institute.
- 13 applications were received from people who live in Equity Emphasis Areas.



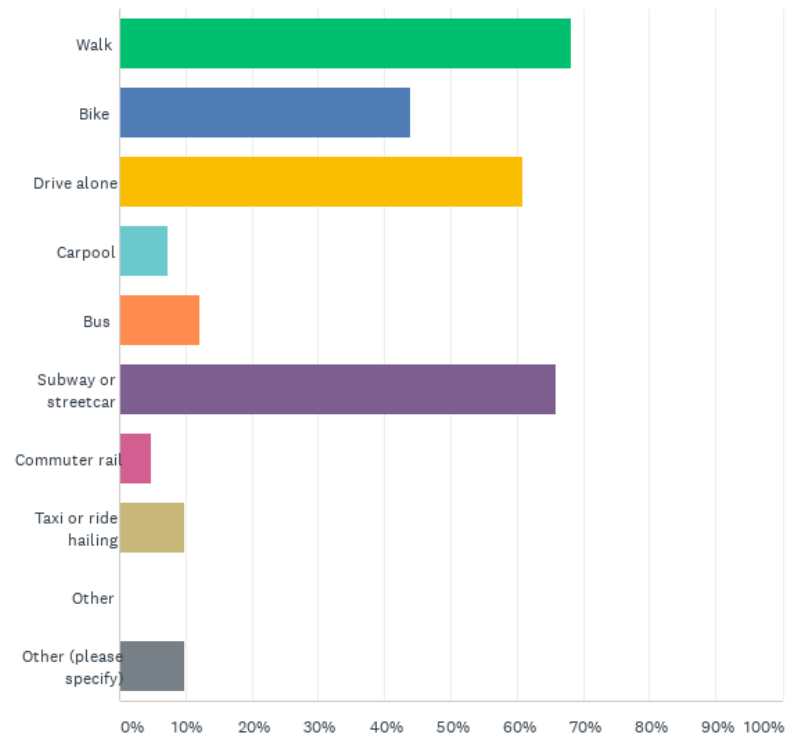

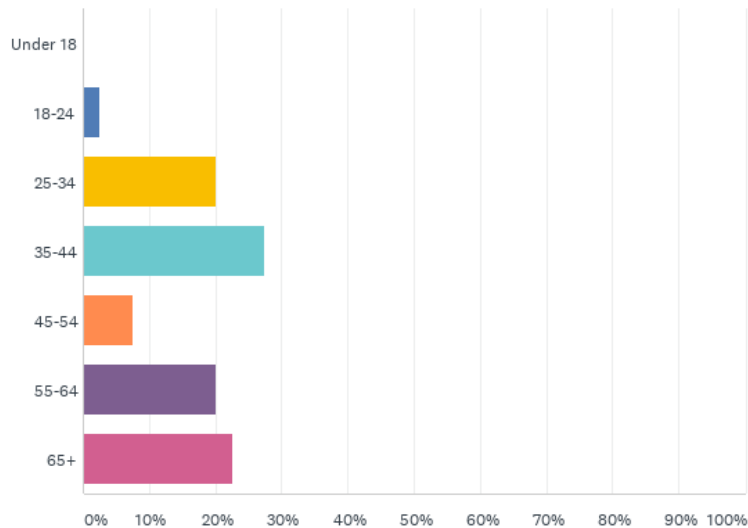
Application Mode Preference

Q6 How do you normally get around the Washington region? Select your three primary modes of transportation.

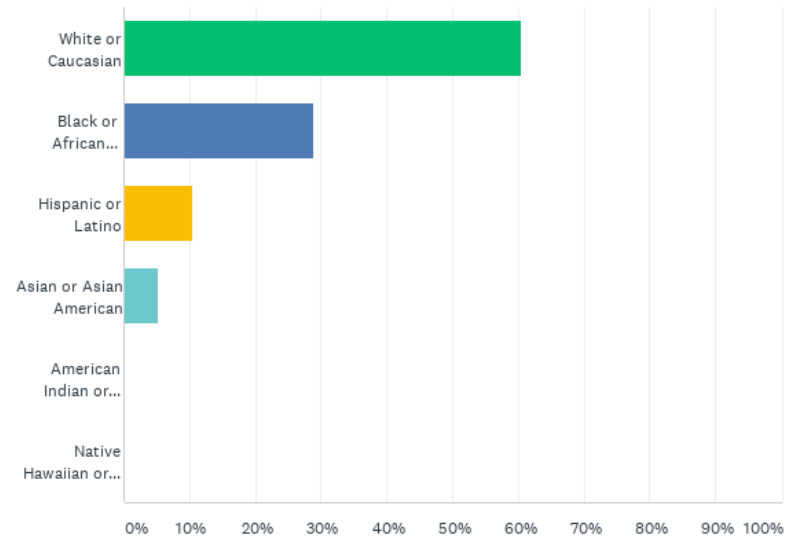


Application Demographics

Selection Criteria

The selection criteria are designed to select members to represent the TPB subregions and as many member jurisdictions as possible. They will also seek to balance racial and ethnic diversity and a variety of transportation perspectives. Possible criteria include:

- **TPB member jurisdiction** – when deciding between two similarly qualified applicants, priority may be given to the person who lives in a member jurisdiction that has not recently been represented on the committee.
- **Past CAC service** – priority may be given to members in good standing.
- **Completion of the Community Leadership Institute** – priority may be given to applicants who have completed CLI.
- **Service on another transportation advisory committee** – priority may be given to applicants who have served on local advisory committees
- **Lives in an Equity Emphasis Area**
- **Demographics**



Next Steps

- **Staff selections** – Using the selection criteria, staff shared recommendations with the 2021 TPB officers.
- **Officer nominations** – The TPB officers will review applications and staff recommendations and make final nominations for the 2021-2022 CAC.
- **Nominations** - Will be distributed to the board with mailout materials for the January 21, 2021 TPB meeting.
- **Approval** – At the January TPB meeting the board will discuss and approve the nominations for the 2021-2022 CAC. The board can make changes to the nominations and vote on those changes at this time.
- **First meeting** – The 2021-2022 CAC meets for the first time in February.
