The synthesis highlights the results of previous and existing bus priority efforts in the NCR, including the TPB's Transportation Investments Generating Economic Recovery (TIGER) Bus Priority Projects, the Bus Transformation Project, and other bus priority projects in the region. It also draws on existing literature to highlight the benefits and costs of bus priority projects as well as examples from other cities. The synthesis concludes with an overview of ongoing and future projects in the NCR.
