#### CHESAPEAKE BAY

## Gov. McAuliffe - New Chair of Chesapeake Executive Council

Virginia Gov. Terry McAuliffe has been selected to chair the Chesapeake Executive Council (EC) in 2015, succeeding the outgoing Maryland Gov. Martin O'Malley. The EC is the overall policy making entity for the Chesapeake Bay Program. It consists of the governors of the six Bay partner states, the mayor of the District of Columbia, the Chesapeake Bay Commission chair and the administrator of the Environmental Protection Agency.

## Chesapeake Bay Management Strategies

The new <u>Bay Agreement</u> (June 2014) identified five major themes and ten goals, and committed the partnership to develop Management Strategies to address those goals. These strategies are being developed now, with the <u>draft management strategies slated to be posted for public review on March 16<sup>th</sup>. The formal public comment period is expected to be 45-days, ending on April 15<sup>th</sup>.</u>

#### STORMWATER

#### Maryland Stormwater Bill SB 863

The Maryland General Assembly has taken final action on legislation (SB 863) to repeal the requirement that all the local governments with Phase I MS4 stormwater permits establish stormwater utility fees. The House of Delegates amended the Senate version of the bill; this House-amended version that was approved by the Senate on April 13 and it is now awaiting the signature of Governor Hogan.

## **Multi-Sector Working Group**

COG's Multi-Sector Working Group will next meet on May 8<sup>th</sup>. The working group, with consultant support, will examine implementable local, regional, and state greenhouse gas reduction strategies in four sectors - Energy, Transportation, Land Use, and Built Environment. The workgroup will quantify benefits, costs, and potential implementation timeframes for greenhouse gas reduction actions and consider exploration of greenhouse gas reduction goals for all sectors. WRTC will have additional opportunity for input on future stages of the project. An interim report is expected September 30, 2015 and final report expected January 2016.

At their January 16th meeting, the Chesapeake Bay Policy Committee formed a Workgroup to track national and state water legislation, and to facilitate fast comment on key bills, as well as to be advocates for the Bay restoration and local water resources issues. ## **EPA Cybersecurity Workshop**

COG will be hosting an EPA cybersecurity workshop for water and wastewater utilities on **April 30**<sup>th</sup>. The workshop will provide water and wastewater utilities with information about the cyber threat, ways to manage the threat, and tools (such as AWWA's cybersecurity tool) available to help utilities. This event will also include a facilitated response exercise using a realistic cyber threat scenario, allowing all participants to talk through the actions they would take in response to the threat. The goal is to identify general planning or procedural gaps in cybersecurity practices that can then be corrected.

#### Regional Source Water Assessment with Corona Environmental Consulting

Over the next year, COG will be working with water utilities in the region and Corona Environmental Consulting to conduct a regional source water assessment and develop a related data system. We will also be working on the development of regional decontamination/flushing protocols for drinking water systems. An important outcome will

be the development of an information system that will facilitate the organization, maintenance, and delivery of essential information about storage of chemicals in the critical zone near drinking water intakes and produce a detailed methodology of how this information can be located, extracted, quality controlled, and maintained. The dual focus on improved data stewardship and tool development will help all stakeholders meet pressing immediate needs and will contribute to meeting longer term needs by turning data into knowledge. This work is being done in conjunction with two Water Research Foundation (WRF) projects:

- a. Project 4572: "Flushing Guidance for Consumer Premise Plumbing and Service Lines to Avoid or Address a Drinking Water Advisory."
- b. Project 4581: "GIS to Identify and Catalog Potential Contaminants Stored in Tanks Upstream of Drinking Water Intakes".

Two USGS studies of the toxicity of runoff from coal-tar-based seal coated pavement and effects of that runoff on DNA have just been published in the scientific journals *Environmental Science and Technology* and *Science of the Total Environment*. The studies were done to address the concern that rainfall runoff occurring within hours or days of coal-tar-based sealant application might be toxic to fish and other organisms in streams. The two studies collected and tested simulated runoff at various times beginning just hours after coal-tar-sealant application. Coal-tar sealants have significantly higher levels of PAHs and related compounds compared to asphalt-based pavement sealants and other urban sources, including vehicle emissions, used motor oil, and tire particles.
