Economic Trends in Metropolitan Washington, 1998 - 2002

Population - The region grew by more than 409,100 people between 1998 and 2002. The inner suburbs grew the most in terms of the absolute number of people, but the outer suburbs had the greatest percentage increase in population. According to COG's Draft Round 6.3 Cooperative Forecasts, the number of people in the region will grow by more than 34 percent by the year 2030.

Employment - After increasing from 2.32 million jobs in 1997 to 2.37 million in 1998, the number of jobs in the area rose to 2.58 million in 2002. According to COG's Draft Round 6.3 Cooperative Forecasts, the number of jobs in the region will grow by more than 46.3 percent by the year 2030.

Federal Spending - The federal government spent \$87.5 billion in the region in 2002, up from \$79.2 billion in 2001. For the sixth time, local federal procurement exceeded salaries and wages. The District of Columbia was home to \$33.5 billion of federal spending, Northern Virginia received \$31 billion, and suburban Maryland received \$22.9 billion.

Labor Force - Between 1998 and 2002, unemployment in the region's workforce increased from 3.2 percent to 3.7 percent. Unemployment in the District of Columbia, at 6.4 percent in 2002, remained higher than in the suburban jurisdictions, which averaged 3.3 percent.

Construction - Construction in the metropolitan Washington region increased slightly during 2002. Developers broke ground on nearly 33.6 million square feet of commercial projects — an increase of nearly 1.4 million square feet from 2001. Led by Loudoun County, local governments issued building permits for more than 34,967 new housing units, up slightly from 2001.

Mortgage Rates, Home Sales, and Housing-Related Inflation – Mortgage rates continued to fall in 2002 to a low of 6.2 percent (fourth quarter), averaging approximately 6.7 percent for the year. The number of homes sold in the region was nearly 93,053 in 2002. Housing-related inflation, as measured by the housing component of the Consumer Price Index for All Urban Consumers (CPI-U), decreased from 3.8 percent between 2000 and 2001 to 2.4 percent between 2001 and 2002.

Inflation - The rate of change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Washington-Baltimore DC-MD-VA-WV CMSA declined from 2.6 percent between 2000 and 2001 to 2.4 percent between 2001 and 2002. The decline was due to lower costs of apparel and transportation (motor fuel).

Income - Total personal income in the Washington region grew by an average of 8.4 percent per year between 1997 and 2001, leading to a 2001 total of \$199.5 billion. On a per capita basis, 2001 income varied greatly by jurisdiction, with a regional average of \$42,726.

Retail Sales - Retail sales in the region increased both in current and real terms between 1998 and 2002. The area's 2002 total annual retail sales of \$60.5 billion was slightly greater than the total in 2001 of \$59.5 billion, and slightly more than the 2000 total of \$60.2 billion.

Airline Passengers - More than 49 million passengers flew into or out of the Washington region's three major airports in 2002, a 5.4 percent increase from 1998.



Overview of Economic Trends in Metropolitan Washington, 1998 - 2002

INTRODUCTION

Economic Trends in Metropolitan Washington is an annual publication of the Metropolitan Washington Council of Governments. This year's report focuses on economic trends between the years 1998 and 2002, and is divided into sections covering population, employment, federal expenditures and obligations, labor force, construction, retail sales, mortgage rates and home sales, personal income, inflation, and transportation.

Throughout the report, information is presented at different levels of geographic specificity. These levels and their components are outlined below.

The Membership of the Metropolitan Washington Council of Governments (Jurisdictions with an asterisk in the map)

Members of the Metropolitan Washington Council of Governments are the District of Columbia; Frederick County, Montgomery County, Prince George's County, and the Cities of Bowie, College Park, Gaithersburg, Greenbelt, Rockville, and Takoma Park in Maryland; and Arlington County, Fairfax County, Loudoun County, Prince William County, and the Cities of Alexandria, Fairfax, Falls Church, and Manassas in Virginia.

The Washington DC-MD-VA Metropolitan Statistical Area (MSA) (see map), as defined by the Office of Management and Budget in 1983, extends beyond the membership of the Council of Governments. It includes the District of Columbia; Calvert County, Charles County, Frederick County, Montgomery County, and Prince George's County in Maryland; and

Arlington County, Fairfax County, Loudoun County, Prince William County, Stafford County, and the Cities of Alexandria, Fairfax, Falls Church, Manassas, and Manassas Park in Virginia. Note that different data items are available for different levels of geographic specificity. See Appendix A for more details.

Central Jurisdictions

The central jurisdictions are defined as the District of Columbia, Arlington County, and the City of Alexandria.

Inner Suburbs

The inner suburbs are Montgomery County, Prince George's County, Fairfax County, and the Cities of Fairfax and Falls Church.

Outer Suburbs

The outer suburbs are defined as Calvert County, Charles County, Frederick County, Loudoun County, Prince William County, Stafford County, and the Cities of Manassas and Manassas Park.

Washington Primary Metropolitan Statistical Area (PMSA)


As a result of the 1990 Census, the Office of Management and Budget (OMB) has modified the definition of metropolitan areas for federal statistical purposes. Under the new definition, the Washington PMSA, the Baltimore PMSA, and the Hagerstown PMSA have been combined into a new Consolidated Metropolitan Statistical Area (CMSA). The individual PMSAs are now expanded and separately recognized as PMSAs. Unless otherwise noted, this report continues to use the 1983 OMB definition of the MSA.


POPULATION


The region grew by more than 409,100 people between 1998 and 2002. The majority of this growth in absolute numbers occurred in the region's inner suburbs, which increased by 191,700 people or 7.4 percent. The region's central jurisdictions had a net gain of 66,800 people, or 8.1 percent. The outer suburbs had the greatest percentage increase in the region, 16.3 percent, with the addition of 150,600 people.

Despite the dramatic growth rate in the outer suburbs, population remains anchored in the inner suburbs, where 59 percent of the region's population lives.

According to COG's Draft Round 6.3 Cooperative Forecasts, the inner suburbs will remain the most populous "ring" of the region well into the next decade. COG forecasts that in the year 2030, the region will hold more than 6.1 million people (34 percent more than the 2000 population). A full 54 percent of the 2030 population is expected to live in the inner suburbs.









EMPLOYMENT¹

While minor growth in employment took place during the first half of 2002, employment declined during the second half of the year resulting in an overall job decline in 2002 compared to 2001. From 2000 to 2001, the Washington region added 30,258 jobs. Between 2001 and 2002, the region lost 1,989 jobs. As a result, the total number of jobs remained at 2.58 million in 2002.


Between 1998 and 2002, more than 44 percent of the total job growth occurred within the inner suburbs, followed by the outer suburbs with 33 percent and the central jurisdictions with 23 percent. More than 51 percent of the region's jobs, 1.3 million, remain in the inner suburbs.


According to COG's Draft Round 6.3 Cooperative Forecasts, the inner suburbs and central jurisdictions will remain the region's employment center into the next decade. In the year 2030, 31 percent of all jobs will be in the central jurisdictions, around 50 percent in the inner suburbs, and 19 percent in the outer suburbs.






FEDERAL SPENDING

Federal spending in the Washington region increased to \$87.5 billion in 2002, from \$79.2 billion in 2001. More than 42.7 percent, or \$37.3 billion, came in procurement contract awards that, for the sixth time, exceeded expenditures in the region for salaries and wages. Nearly \$25.3 billion, or more than 28.9 percent of the spending, for salaries and wages. More than 27 percent of the region's federal spending was from the Department of Defense.

The District of Columbia received more federal spending than either Northern Virginia or suburban Maryland, with less than half of the District total going toward salaries and wages. Northern Virginia received a large percentage of its federal funds from procurement contract awards, while suburban Maryland's total was split among procurement, retirement and disability payments, and salaries and wages.






LABOR FORCE²

Between 1998 and 2002 the civilian labor force in the Washington DC-MD-VA-WV PMSA increased by 264,000 people, to a total of 2,823,000. Of that number, 2,719,800 were employed and 103,200 were unemployed, putting the unemployment rate for the civilian labor force in the Washington DC-MD-VA-WV PMSA at 3.7 percent in 2002. The unemployment rate in the region has increased steadily during the last five years, from 3.2 percent in 1998 to the 2002 figure of 3.7 percent.

Unemployment in the District of Columbia, at 6.4 percent in 2002, remained higher than in suburban jurisdictions, which averaged 3.3 percent.



CONSTRUCTION

Commercial construction in the metropolitan Washington region increased slightly during 2002, with developers breaking ground on more than 33.6 million square feet of space. In 2002, commercial construction in the region increased from the 2001 total of 32.2 million, but far below the 2000 total of 48.6 million. Montgomery County saw the most new commercial construction with more than 7.9 million square feet, followed by the District of Columbia with more than 6.5 million square feet.

The number of new, privately, owned housing units authorized in the region increased slightly from 32,775 in 2001 to 34,967 in 2002. Of the permits that were issued in 2002, over half were in the outer suburbs.



MORTGAGE RATES, HOME SALES, AND HOUSING-RELATED INFLATION

Mortgage Rates


Mortgage rates continued to fall between 1998 and 2002 to a low of 6.2 percent in 2002 (fourth quarter). Average rates fell from 7.2 percent in 2001 to 6.7 percent in 2002.

Homes Sold

The number of homes sold in the region jumped dramatically between 1998 and 2002, from 63,281 units in 1998 to 93,053 units in 2002. Fairfax County had the most homes sold in 2002 with 22,303.

Housing-Related Inflation

The rate of change in the Consumer Price Index for housing in the Washington-Baltimore DC-MD-VA-WV CMSA decreased from 3.8 percent between 2000 and 2001 to 2.4 percent between 2001 and 2002. Nationally, housing inflation increased from 4.0 percent between 2000 and 2001 to 2.2 percent between 2001 and 2002. This measure accounts for price changes in rents and mortgage payments, owner costs, fuels, furnishings, and household supplies.




INFLATION

The rate of change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Washington-Baltimore DC-MD-VA-WV CMSA declined from 2.6 percent between 2000 and 2001 to 2.4 percent between 2001 and 2002. Nationally, the rate of change declined from 2.8 percent between 2000 and 2001 to 1.6 percent between 2001 and 2002. The following topical changes were behind the regional inflation rate:



INCOME

Total personal income in the Washington region grew by an average annual rate of 8.4 percent between 1997 and 2001, leading to a 2001 total of \$199.5 billion. Total income growth was fastest in the outer suburbs, where income increased by an average of 10.8 percent per year.

On a per capita basis, income varied greatly by jurisdiction. Fairfax County topped the region in per capita income at \$53,721. Stafford County had the lowest per capita income at \$27,726. The per capita income for the region was \$42,726 in 2001.



RETAIL SALES

Retail sales in the region increased both in current and real terms between 1998 and 2002. However, the area's 2002 total of \$60.5 billion, when adjusted for inflation, was greater than total annual retail sales in 2001, \$59.5 billion, and slightly more than the 2000 total of \$60.2 billion.


When adjusted for inflation, retail sales in the region increased by 12 percent between 1998 and 2002. Nationally, sales increased by 10.9 percent.

AIRLINE PASSENGERS

More than 49 million passengers flew into or out of the Washington region's three major airports in 2002, a 5.4 percent increase from 1998. Baltimore-Washington International led the three airports in total airline passengers served, with 19 million. 17.1 million passengers passed through Washington-Dulles International, while Reagan National served 12.9 million. Reagan National continued to experience the effects of the September 11th attack, with commercial passenger service down by 18 percent since 2000.





EMPLOYMENT⁴

While there was minor growth in employment took place during the first half of 2002, employment declined during the second half of the year resulting in an overall job decline in 2002 compared to 2001. From 2000 to 2001, the Washington region added 30,258 jobs. Between 2001 and 2002, the region lost 1,989 jobs. As a result, the total number of jobs remained at 2.58 million in 2002.

Between 1998 and 2002, more than 44 percent of the total job growth occurred within the inner suburbs, followed by the outer suburbs with 33 percent and the central jurisdictions with 23 percent. More than 51 percent of the region's jobs, 1.3 million, remain in the inner suburbs.


According to COG's Draft Round 6.3 Cooperative Forecasts, the inner suburbs and central jurisdictions will remain the region's employment center into the next decade. In the year 2030, 31 percent of all jobs will be in the central jurisdictions, around 50 percent in the inner suburbs, and 19 percent in the outer suburbs.





FEDERAL SPENDING


Federal spending in the Washington region increased to \$87.5 billion in 2002, from \$79.2 billion in 2001. More than 42.7 percent, or \$37.3 billion, came in procurement contract awards which, for the sixth time, exceeded expenditures in the region for salaries and wages. Nearly \$25.3 billion, or more than 28.9 percent of the spending, for salaries and wages. More than 27 percent of the region's federal spending came from the Department of Defense.

The District of Columbia received more federal spending than either Northern Virginia or suburban Maryland, with less than half of the District total going toward salaries and wages. Northern Virginia received a large percentage of its federal funds from procurement contract awards, while suburban Maryland's total was split among procurement, retirement and disability payments, and salaries and wages.

LABOR FORCE⁵

Between 1998 and 2002 the civilian labor force in the Washington DC-MD-VA-WV PMSA increased by 264,000 people, to a total of 2,823,000. Of that number, 2,719,800 were employed and 103,200 were unemployed, putting the unemployment rate for the civilian labor force in the Washington DC-MD-VA-WV PMSA at 3.7 percent in 2002. The unemployment rate in the region has increased steadily during the last five years, from 3.2 percent in 1998 to the 2002 figure of 3.7 percent.

Unemployment in the District of Columbia, at 6.4 percent in 2002, remained higher than in suburban jurisdictions, which averaged 3.3 percent.




CONSTRUCTION

Commercial construction in the metropolitan Washington region increased slightly during 2002, with developers breaking ground on more than 33.6 million square feet of space. In 2002, commercial construction in the region increased from the 2001 total or 32.2 million, but far below the 2000 total of 48.6 million. Montgomery County saw the most new commercial construction with more than 7.9 million square feet, followed by the District of Columbia with more than 6.5 million square feet.

The number of new, privately, owned housing units authorized in the region increased slightly from 32,775 in 2001 to 34,967in 2002. Of the permits that were issued in 2002, nearly half were in the outer suburbs.



MORTGAGE RATES, HOME SALES, AND HOUSING-RELATED INFLATION

Mortgage Rates

Mortgage rates continued to fall between 1998 and 2002 to a low of 6.2 percent in 2002 (fourth quarter). Average rates fell from 7.2 percent in 2001 to 6.7 percent in 2002.

Homes Sold

The number of homes sold in the region jumped dramatically between 1998 and 2002, from 63,281 units in 1998 to 93,053 units in 2002. Fairfax County had the most homes sold in the region in 2002, with 22,303.


Housing-Related Inflation

The rate of change in the Consumer Price Index for housing in the Washington-Baltimore DC-MD-VA-WV CMSA decreased from 3.8 percent between 2000 and 2001 to 2.4 percent between 2001 and 2002. Nationally, housing inflation decreased from 4.0 percent between 2000 and 2001 to 2.2 percent between 2001 and 2002. This measure accounts for price changes in rents and mortgage payments, owner costs, fuels, furnishings, and household supplies.



INFLATION

The rate of change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Washington-Baltimore DC-MD-VA-WV CMSA declined from 2.6 percent between 2000 and 2001 to 2.4 percent between 2001 and 2002. Nationally, the rate of change declined from 2.8 percent between 2000 and 2001 to 1.6 percent between 2001 and 2002. The following topical changes were behind the regional inflation rate:



INCOME


Total personal income in the Washington region grew by an average annual rate of 8.4 percent between 1997 and 2001, leading to a 2001 total of \$200 billion. Total income growth was fastest in the outer suburbs, where income increased by an average of 11 percent per year.

On a per capita basis, income varied greatly by jurisdiction. Fairfax County topped the region in per capita income at \$53,721. Stafford County had the lowest per capita income at \$27,726. The per capita income for the region was \$42,726 in 2001.



RETAIL SALES


Retail sales in the region increased both in current and real terms between 1998 and 2002. However, the area's 2002 total of \$60.5 billion, when adjusted for inflation, was greater than the total annual retail sales in 2001, \$59.5 billion, and slightly more than the 2000 total of \$60.2 billion.

When adjusted for inflation, retail sales in the region increased by 12 percent between 1998 and 2002. Nationally, sales increased by 10.9 percent.


AIRLINE PASSENGERS

More than 49 million passengers flew into or out of the Washington region's three major airports in 2002, a 5.4 percent increase from 1998. Baltimore-Washington International led the three airports in total airline passengers served, with 19 million. 17.1 million passengers passed through Washington-Dulles International, while Reagan Washington National Airport served 12.9 million. Reagan National continued to experience the effects of the September 11th attack, with commercial passenger service down by 18 percent since 2000.
