FY 2012 TIGER Grant Announcement

- Notice of Funding Availability (NOFA) published January 31.
 - Pre-application due: February 20
 - Application due: March 19
 - In contrast to the three previous rounds of TIGER, the application timeframe is only 7 weeks.
- \$500 million for funding capital projects.
 - Awards take into consideration geographic and modal equity (\$120 million reserved for rural projects).
 - Minimum Federal funds application amount: \$10 million (urban).
 - Must be obligated by Sep. 30, 2013.
- Requires minimum of 20% local match.
 - Urban projects awarded FY 2011 TIGER Grants averaged 65% non-Federal funds.
 - Higher match and private contributions make applications more competitive.

FY 2011 TIGER Grants and TPB Application Debrief

FY 2011 TIGER Grants Overview

- Nationally, a total of 848 applications requesting \$14.20 billion.
- Awards made for 46 projects (5.4%), total of \$511 million (3.6%).
- Largest award for any project was \$20 million.
 - TPB's FY 2011 Application for *Multimodal Access Improvements for Rail Station Areas* (\$24.3 million) not successful.
 - Out of applications in this region, Virginia DOT was only successful applicant: \$20 million for a TIFIA payment for the I-95 HOT Lanes.

TPB's FY 2011 Application Debrief by USDOT

- Concept very well-received: "hit it out of the park". Strong encouragement to re-submit.
- Emphasized <u>Project Readiness</u> and <u>Local Commitment</u>:
 - More information on project schedule and ability to begin quickly.
 - Higher local match; zoning and development plans.


TPB's FY 2012 TIGER Application

- Based on short timeframe and positive USDOT feedback, staff recommend submitting an update of the FY 2011 application
 - Concept of small-scale, innovative improvements to improve access to the region's rail stations is compelling.
 - Planning has continued on several of the proposed component projects, increasing project readiness.
 - Project budgets have been streamlined as planning has advanced.
 - Greater local matching funds may be possible.

TPB FY 2011 Grant Application

- Seven component projects across the region, at 8 Metrorail and 8 VRE stations. Project totaled \$31.1 M (\$24.2 M Federal / \$6.8 M (22%) local match).

Final Steps for FY 2012 TIGER Grant Application Submission

- Pass TPB Resolution R10-2012 approving the submission of a pre-application and final application.
 - March 21 TPB meeting follows the final application submission date.
- TPB and Regional staff will prepare revised Application Narrative, Project Schedules and Budgets, and Benefit-Cost Analysis.
- Collect Letters of Support.
 - City and County Councils, Members of Congress, Citizen Associations, and Commercial Firms
- Submit application by March 19.

 million (\$13.4 M federal / \$3.3 M (20%) local match).
