TPB Begins Travel Survey of 10,000 Households

The Transportation Planning Board is launching the region's first large-scale household travel survey in more than a decade. At the TPB meeting on January 17, Bob Griffiths of the TPB staff explained that the survey will help guide future transportation planning.

Beginning this month, the TPB's Household Travel Survey will assess the travel behaviors of 10,000 randomly-selected area households. The survey will be used to develop new forecasting models for use in future transit and highway planning. As the region faces a predicted 1.6 million more residents by 2030, the survey will

also help local governments figure out which transportation improvement projects will benefit their growing communities most.

"The information we expect to gain from this survey will be invaluable in determining how to relieve future congestion on our roadways and transit systems," said TPB Chair Catherine Hudgins. "The individuals and families who



agree to take part will be providing us with essential information that we simply cannot obtain without their help."

The TPB has contracted with transportation research firm NuStats to survey between 800 and 900 households each month through January 2008. Participants will be asked to keep a record of all travel made by family members, from commuting to work and school to trips to ATM machines, for a period of 24 hours. Participants will also be asked about personal activities such as online shopping that replace errands residents would otherwise be making by car.

Interviews will be conducted in both English and Spanish. Households will be selected at random from the TPB's member jurisdictions

and adjacent areas.

TPB member Kathy Porter emphasized that the Household Travel Survey affords regular citizens the opportunity to participate in an important process for transportation planning in the region. "Clearly traffic congestion and difficulties getting around are one of the big issues people are concerned about," said Ms. Porter, who is mayor of Takoma Park. "People should know that this is the data that we are going to use to make future transportation plans, and this is an opportunity to assist in addressing some of those problems in getting around."

Federal Policy Released on Transit Funding for Variably Priced Lanes

The Federal Transit Administration (FTA) on January 11 issued a final policy stating that transit formula funding under the "fixed-guideway miles" classification shall be available for HOV lanes that are converted to high-occupancy/toll (HOT) lanes. However, the policy statement stopped short of making those funds available to newly constructed HOT lanes or other variably priced lanes.

Last October, the TPB sent comments to FTA requesting that all variably priced lanes that provide for unimpeded transit service should be classified as "fixed guideway miles" in the FTA transit funding formulas. The TPB comments noted that "In this region, existing exclusive HOV lanes which can be used by transit, carpool and vanpool vehicles have been classified by FTA as 'fixed guideway' miles because they provide for unimpeded transit service. It is only logical that all variably-priced lanes which provide for unimpeded transit service should be classified as "fixed guideway" miles and be included in the federal transit funding formulas."

FTA did not accept this recommendation, noting that the agency would defer to Congress for a determination of whether and how new facilities would be counted in the formula.

Under the new FTA policy, the "fixed guideway" formula funds would not apply to new variably priced facilities currently in the region's long-range transportation plan, including new HOT lanes along 15 miles of the Capital Beltway and the InterCounty Connector in Maryland. In contrast, the formula funds could be available on sections of I-395 in Virginia where HOV lanes may be converted to HOT lanes.

Other January Agenda Items


ther items on the TPB's January 17 agenda included the following:

- Approval of the establishment of a Regional Bus Subcommittee. The mission of this new subcommittee, which will report to the TPB Technical Committee, is to "provide a permanent process for the coordination of bus planning throughout the Washington region, and for incorporating regional bus plans into the Constrained Long-Range Plan (CLRP) and Transportation Improvement Program (TIP)." The TPB's current work program was amended to include \$50,000 for this new group. - Briefing on the draft FY 2008 Unified Planning *Work Program (UPWP)*. Ron Kirby, Director of the Department of Transportation Planning, described the draft UPWP, which is the TPB's annual work program. He said the UPWP totals \$11.75 million and reflects a number of key considerations, including new requirements of the 2005 federal transportation reauthorization (SAFETEA-LU), recommendations of the March 2006 federal certification review of the TPB planning process, and additional initiatives that have recently been put into the TPB's work program. - Approval of an amendment to the FY2007 UPWP to fund Phase I of the planning and funding of a bicycle route-finding website for the Washington region. The board added \$33,000 to this year's work program to initiate development of a website for bicyclists similar to that provided for motorists by Mapquest

• Extension of deadline for applications for Technical Assistance under the

Transportation/Land **Use Connections (TLC)** program. The board agreed to extend the deadline for TLC applications from January 31 to February 28. - Approval of three appointments to the TPB Citizens Advisory Committee. The board approved three CAC appointments for Virginia: Steve Cerny, Jim Larsen and Alexandra Simpson. TPB Chairman Cathy Hudgins appointed Jim Larsen to be CAC chair for 2007.
- Approval of revised schedule for the 2007 Constrained Long-Range Plan (CLRP) and the FY2008-2013 Transportation Improvement Program (TIP. Under the new schedule the TPB will be asked on April 18 to approve the CLRP/TIP project submissions for inclusion in the air quality conformity analysis. Final approval of the CLRP and TIP is scheduled for November 21, 2007. For more information, go to www.mwcog.org/transportation/tpb, and see Item 11 under the past meeting documents for January 17.
- *Update on the Washington Region Metropolitan Area Transportation Operations Coordination (MATOC) program.* Andy Meese of the COG/TPB staff explained that in the coming weeks, the four major transportation agencies involved in MATOC are expected to sign a multi-state agreement that will permit the program to move forward.
