At its meeting on March 3, 2023, the TPB Steering Committee adopted four resolutions approving amendments to the FY 2023-2026 Transportation Improvement Program (TIP) as requested by the District Department of Transportation (DDOT), the Virginia Department of Transportation (VDOT) and others, as described below:

- TPB SR18-2023 requested by DDOT to add net total of \$5 million by decreasing funding for the Safety Improvements Citywide program by \$1.5 million and adding \$6.5 million in funding for a new Traffic Safety Input program (and reprogramming \$495,000 from the Retro-flective Backplates program to the Traffic Signal Maintenance Program. All four operational programs are exempt from the air quality conformity requirement.
- TPB SR19-2023 requested by DDOT on behalf of the TPB to add \$312,500 for implementation
  of a "Vanpool MicroTransit Pilot Program" to be administered by Commuter Connections and
  funded with Enhancing Mobility Innovation competitive grant program. This program is
  exempt from the conformity requirement. The TPB's portion of the TIP is included in DDOT's
  STIP for funding purposes.
- TPB SR20-2023 requested by VDOT to add a net total of \$55.5 million for the VA Route 286 Popes Head Road Interchange project, VRE's Rolling Stock Acquisition program, and for PRTC's Commuter Assistance Program, three bus maintenance/replacement programs, and a new bus shelter program. The Popes Head Interchange project was included in the most recent conformity analysis of the Plan and TIP and the six transit ongoing programs are exempt from the conformity requirement.
- TPB SR21-2023 requested by FHWA to include 20 projects in the District of Columbia, 13 projects in suburban Maryland, and 9 projects in Northern Virginia from the Eastern Federal Lands Highway Division's FY 20203–2026 TIP in the TPB's TIP. FHWA has requested that these three sets of projects be included as appendices to each of the three DOT's STIPs. These projects are located on lands managed by Federal Land Management Agencies and funded by either the Federal Lands Transportation Program (FLTP) or Federal Lands Access Program (FLAP). They are all exempt from the air quality conformity requirement.

The TPB Bylaws provide that the Steering Committee "shall have the full authority to approve non-regionally significant items, and in such cases, it shall advise the TPB of its action." The director's report each month and the TPB's review, without objection, shall constitute the final approval of any actions or resolutions approved by the Steering Committee.

RESOLUTION ON AN AMENDMENT TO THE FY 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) THAT IS EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT TO INCLUDE TIP ACTION 23-13.1 WHICH REPROGRAMS FUNDING ON FOUR ONGOING OPERATIONS AND MAINTENANCE PROGRAMS, AS REQUESTED BY THE DEPARTMENT OF TRANSPORTATION (DDOT)

WHEREAS, the National Capital Region Transportation Planning Board (TPB), as the federally designated metropolitan planning organization (MPO) for the Washington region, has the responsibility under the provisions of the Infrastructure Investment and Jobs Act (IIJA) which was signed into law on November 15, 2021, for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the metropolitan area; and

**WHEREAS**, the TIP is required by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) as a basis and condition for all federal funding assistance to state, local and regional agencies for transportation improvements within the Washington planning area; and

WHEREAS, on June 15, 2022 the TPB adopted the FY 2023-2026 TIP; and

WHEREAS, DDOT has requested an amendment to the FY 2023-2026 TIP to include TIP Action 23-13.1 which adds a net total of \$5 million by decreasing funding for the Safety Improvements Citywide program (T3212) by \$1.5 million and adding \$6.5 million in funding for a new Traffic Safety Input program (T11625) and reprogramming \$495,000 from the Retroflective Backplates program (T6811) to the Traffic Signal Maintenance Program (T5347), as described in the attached materials; and

### WHEREAS, the attached materials include:

**WHEREAS**, these programs have been entered into the TPB's Project InfoTrak database under TIP Action 23-131, creating the 13<sup>th</sup> amended version of the FY 2023-2026 TIP, which supersedes all previous versions of the TIP and can be found online at <a href="https://www.mwcog.org/ProjectInfoTrak">www.mwcog.org/ProjectInfoTrak</a>; and

WHEREAS, these programs are exempt from the air quality conformity requirement; and

**WHEREAS**, this resolution and amendments to the FY 2023-2026 TIP shall not be considered final until the Transportation Planning Board has had the opportunity to review and accept these materials at its next full meeting.

NOW, THEREFORE, BE IT RESOLVED THAT the Steering Committee of the National Capital Region Transportation Planning Board amends the FY 2023-2026 TIP to include TIP Action 23-13.1 adds a net total of \$5 million by decreasing funding for the Safety Improvements Citywide program (T3212) by \$1.5 million and adding \$6.5 million in funding for a new Traffic Safety Input program (T11625) and reprogramming \$495,000 from the Retroflective Backplates program (T6811) to the Traffic Signal Maintenance Program (T5347), as described in the attached materials.



Description

The TOSD plans to implement retroreflective backplates as a safety improvement to reduce fatalities and serious injury crashes on the Districts roadways. Retroreflective backplates are FHWA Proven Safety Countermeasure known to reduce total crashes at an intersection by 15%, by providing greater visibility and conspicuity of traffic signal heads, particularly at night and for drivers with vision limitations. The project will include systemic installation of this measure on corridors identified through network screening in each of the eight wards, as well as similar installation for single intersections that demonstrate characteristics and a safety record of crashes susceptible to correction with this treatment.

The District Department of Transportation (DDOT) requests that the FY 2023-2026 Transportation Improvement Program (TIP) be amended as detailed below.

WHEREAS, the National Capital Region Transportation Planning Board (TPB), which is the metropolitan planning organization (MPO) for the Washington Region, has the responsibility under the provisions of Infrastructure Investment and Jobs Act (IIJA) which was signed into law on November 15, 2021, for developing and carrying out a continuing, cooperative, and comprehensive transportation planning process for the Metropolitan Area; and

**WHEREAS**, the TIP is required by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) as a basis and condition for all federal funding assistance to state, local and regional agencies for transportation improvements within the Washington planning area; and

WHEREAS, on June 15, 2022 the TPB adopted the FY 2023-2026 TIP; and

**WHEREAS**, the IIJA established the EMI program to make competitive grants for the development and/or demonstration of projects that improve mobility and enhance the rider experience with a focus on innovative service delivery models, creative financing, novel partnerships, and integrated payment solutions; and.

**WHEREAS**, on November 12, 2021, FTA announced the opportunity to apply for grant funds under the EMI program; and

**WHEREAS**, COG/TPB staff submitted a grant application on January 11, 2022 titled "Vanpool Microtransit Pilot Program." The project's stated purpose was to accomplish the following:

- 1. Design an open-source, cross platform mobile application to convert existing and future vanpools into microtransit providers to provide additional mobility solutions to environmental justice populations.
- 2. Use partnerships with employers and vanpool operators in the region through Commuter Connections to improve occupancy rates on existing vanpools and set the groundwork for new vanpool formation.
- 3. Create a self-sustaining cycle in which new vanpool formations will provide wider mobility options for commuters and additional microtransit routes; and

WHEREAS, On August 10, 2022, FTA announced EMI funding for nine projects nationally. COG/TPB's "Vanpool Microtransit Pilot Program" project had been selected for funding at the fully requested federal grant dollar amount of \$250,000, The total project budget is \$312,500 which includes \$62,500 matching funds provided by the three state funding agencies; and

**WHEREAS**, on September 14, 2022, the COG Board of Directors adopted Resolution R36-2022 authorizing COG to receive and expend grant funds from the FTA for its EMI Public Transportation Innovation grant; and

Assistance (CFDA) number: 20.530 -- Public Transportation Innovation

DATE: September 21, 2022

COG/TPB staff applied for two grants from the Federal Transit Administration that included the ICAM Pilot and EMI Public Transportation Innovation programs. Each grant application was approved for funding.

The ICAM project is in the amount of \$100,000 in federal funds and \$25,000 in matching funds from the Washington Metropolitan Transit Authority (WMATA) for a total budget of \$125,000. The purpose of the project will be to convene a consortium of regional stakeholders to move the existing Reach a Ride platform towards a one-call, one-click Information and Referral/Assistance tool for transportation options in the region. The grant period of performance will be over a two year timeframe after the grant contract is signed with FTA. The COG Board was asked to approve the receipt of the ICAM grant funds during its July 30, 2022 meeting. Resolution R32-2022 authorizing COG to receive and expend grant funds from the Federal Transit Administration for its ICAM Mobility Pilot Program was approved and COG will act as the administrative agent for the project.

The EMI project is in the amount of \$250,000 in federal funds and \$62,500 in matching funds from the District, Maryland, and Virginia Departments of Transportation from the CCWP for a total budget of \$312,500. The purpose of the project will be to design an open-source, cross platform mobile application to convert existing and future vanpools into microtransit providers to provide additional mobility solutions to environmental justice populations. Partnerships with employers and vanpool operators in the region through Commuter Connections will be used to improve occupancy rates on existing vanpools and set the groundwork for new vanpool formation. This will create a self-sustaining cycle in which new vanpool formations will provide wider mobility options for commuters and additional microtransit routes. The grant period of performance will be over a two year timeframe after the grant contract is signed with FTA. The COG Board was asked to approve the receipt of the EMI grant funds during its September 14, 2022 meeting. Resolution R36-2022 authorizing COG to receive and expend grant funds from the Federal Transit Administration for its EMI Public Transportation Innovation was approved and COG will act as the administrative agent for the project

COG/TPB is currently working on completing applications in TrAMS to receive the funds from FTA and contract with the two subrecipients to manage the grant awards.

The selected firm will work with COG and our member water utilities to refine and implement a strategic legislative plan for COG and partners to execute, including identification of legislation, dates, and member engagement.

SUBJECT: Upcoming Solicitations for Applications for the Transportation Alternatives Set-Aside

Program

**DATE**: March 9, 2023

The next application period in Maryland for the Transportation Alternatives Set-Aside (TA Set-Aside) Program will be April 14 - May 15, 2023.

The TA Set-Aside is a federal program that funds smaller-scale capital improvement projects such as pedestrian and bicycle facilities, trails, safe routes to school (SRTS) projects, environmental mitigation, and other community improvements. Information on the program is available from FHWA at: https://www.fhwa.dot.gov/environment/transportation\_alternatives/.

Under federal law, a portion of the program's funds are suballocated to the TPB, which is responsible for selecting additional projects for our region's portions of DC, Maryland, and Virginia. The TPB is currently expected to approve funding on July 19, 2023, for TA Set-Aside projects in Maryland.

Applications in Maryland must be submitted through the Maryland Department of Transportation (MDOT), which is also responsible for selecting projects using a statewide TA Set-Aside allocation. See <a href="https://www.mdot.maryland.gov">www.mdot.maryland.gov</a> for more information.

Virginia and the District of Columbia both conduct their solicitations on two-year cycles. Their next application periods will be conducted in 2024.

Past recipients of technical assistance through the TPB's Transportation Land Use Connections (TLC) Program are encouraged to consider seeking funding for capital improvements through the TA Set-Aside Program. The TPB also encourages TA Set-Aside applications that support policies highlighted in Visualize 2045, our region's adopted long-range transportation plan. The TPB's selection criteria, which are expected to be used this year, include:

- Focus on expanding nonmotorized transportation options;
- Enhancing roadway safety for walkers and bicyclists;
- Support for Regional Activity Centers;
- Access to high-capacity transit, especially in Transit Access Focus Areas (TAFAs);
- Support for the National Capital Trail Network;
- Access in Equity Emphasis Areas; and
- Increased access for people with disabilities.

SUBJECT: Pretest for Washington-Baltimore Regional Air Passenger Survey, April 16 to 29

**DATE:** March 9, 2023

The 15th Washington-Baltimore Regional Air Passenger Survey (APS) will be conducted in 2023.

This survey is conducted to support the airport system planning and airport ground access planning processes and is part of TPB's Continuous Air Systems Planning Program. The APS collects information about how our visitors and residents travel to Metropolitan Washington's three major commercial airports: Baltimore/Washington International Thurgood Marshall Airport (BWI), Ronald Reagan Washington National Airport (DCA), and Washington Dulles International Airport (IAD). Departing air passengers in the gate holding areas will be asked to respond to a questionnaire that asks about the purpose of their air travel, how they traveled to the airport (drove, rode transit, etc.), and other information.

In advance of the full-scale survey at all three major commercial airports in the fall, a pretest will be conducted this spring to evaluate and refine field methods. Several methodological changes will be implemented this year, including:

- moving from a paper to web-based data collection,
- using handled electronic tablets complimented with an option for participants to take the survey on a personal electric device, and
- offering a raffle incentive to promote survey participation.

The pretest will be conducted at Washington Dulles International Airport from April 16 to 29.
