This is a briefing about the trading programs in Maryland, Virginia and District of Columbia. The District of Columbia's program is focused exclusively on stormwater, whereas Maryland and Virginia allow nutrient trading between the agriculture, wastewater and stormwater sectors.

Discussion will focus on how the trading programs can provide more efficient ways of meeting the Bay TMDL nutrient and sediment reductions, and stormwater and other permit requirements.

What are the opportunities and efficiencies? What could be unforeseen consequences? How are local water quality and wastewater capacity safeguarded?
