2030 Climate and Energy Action Plan (CEAP) Goals

- COG Board adopted goals of:
 - 50% by 2030 below 2005 levels
 - Becoming a Climate Ready Region and making significant progress to be a Climate Resilient Region by 2030



2030 CEAP ZEV Strategies and Targets

- Regional Zero Emission Vehicle (ZEV) Strategies
 - ZEV-1: expand light-duty electric vehicle deployment
 - ZEV-2: accelerate electrification of medium- and heavy-duty vehicles
 - ZEV-3: build out regional electric vehicle charging network
- ZEV Implementation Targets
 - Light-duty BEVs and PHEVs: 30%
 - Light-duty trucks: 9%
 - Medium- and heavy-duty trucks: 4%
 - Transit buses: 30%
