## 10: 25 A.M. 4. CONTAMINANTS OF CONCERN: PAH AND PFAS

Lillian Power, Environmental Protection Specialist, DOEE, and Lynn Thorp, National Campaigns Director, Clean Water Action The CBPC has been tracking two bills in the Maryland General Assembly, that would limit the sources of two classes of chemicals persistent in the environment and which have viable alternatives, these being PAH (polyaromatic hydrocarbons), and a class of chemicals known as PFAS (per- and polyfluoroalkyl substances).
