The Committee will be briefed on the results of an update to this scenario utilizing the 2012 CLRP as the baseline, along with the Version 2.3 travel demand model and the more detailed transportation analysis zone structure.

MAP-21 calls for MPOs, state DOTs and public transportation providers to establish and use a performance-based approach to transportation decision making to support national goals. It calls for USDOT to establish performance measures related to national goals for planning processes and for state DOTs, public transportation providers and MPOs to coordinate and establish performance measures and targets. The Committee will be briefed on the responsibilities of the TPB for measures and targets related to congestion mitigation and air quality.
