## 4. TDM System Update

Stephen Finafrock, COG/TPB staff, began this agenda item by announcing that route-based ridematching is now available for both the Delaware and Charlottesville TDM sites. Mr. Finafrock then logged into the TDM system as a user to demonstrate various route-based ridematching results. Those in attendance were urged to reach out to the commuter support inbox if any technical errors are encountered.

Mr. Finafrock then addressed the reported "too many redirects" error experienced when an admin attempts to create an account with an existing email address. This issue has been fixed and the TDM system now displays the correct error message. COG/TPB Staff is looking into the possibility for the TDM system to provide the current user's profile when attempting to enter an existing email address within the system. Mr. Finafrock then addressed another recent software bug where administrators are unable to add a new employee while in the "Employee Admin" module. Mr. Finafrock encouraged administrators to use the workaround in place until this issue is solved. Administrators can still add an employee by viewing a user's profile, clicking on "Employer Information" then clicking "Update Employer." The admin can then search for the new employer. If it is not found within the TDM system, the administrator will be prompted to enter the employer's information. COG/TPB staff is working with their developers on fixing this issue.

Mr. Finafrock then showcased all the special events that have been loaded into the TDM System by COG/TPB staff. This includes all major sporting events for the region and various community events. George Clark, Tri-County Council for Southern Maryland, suggests that the character limit in the description box be expanded to allow for a more elaborate description of the event being entered. COG/TPB staff will work with their developers on improving this.

Mr. Finafrock then logs into the TDM as a user to display the functionality of the special events module. A special event is selected by the user and added to their profile. The user can then choose to run a special events match by selecting the added event and running a match request. Any other users that have added that same event to their profile will appear as a match.

Mr. Finafrock then encouraged all in attendance to add any special events occurring in their jurisdiction, and he recommended talking about this functionality during the coming marketing events.

Mr. Finafrock also noted that the park and ride section on the Commuter Connections website has been updated. Network members were encouraged to view the information relevant to their jurisdiction and check for any errors or changes that need to be made.

Heidi Mitter, VDOT, asked if park and ride information will be available on the Commuter Connections mobile app. Mr. Finafrock confirmed that the park and ride info is currently available to those using the mobile application.

## 5. Mobile Applications Update

Stephen Finafrock, COG/TPB staff, reiterated that CarpoolNow is available for download for iOS, Android and BlackBerry. Mr. Finafrock also stated that the newest version of the Commuter Connections mobile app is live and available for download. Mr. Finafrock then stated the following download stats for each app by operating system:

Mr. Finafrock then began explaining the various updates that have been made for the newest version of the Commuter Connections mobile app. Users now have the ability to log their trips using their mobile device. This enhancement has been suggested by users and should result in a higher level of participation for those enrolled in an incentive program. COG/TPB staff plans on integrating the Flextime Incentive program into the mobile app. This means giving the app the ability to push out notifications to its users enrolled in the program. More information regarding the flextime integration will be available during the Fall.

Enhancements have been made to the overall look and feel of the Commuter Connections mobile app, which should make it more appealing and intuitive for its users.

## 6. GIS Update

Ross Edgar, COG/TPB staff, updated the Committee on the status of the upcoming bike routing module. Mr. Edgar began by logging into ArcGis online to access the bike-routing web application. As of now, the routing only includes Washington, D.C., and will be expanded throughout the region during FY2018. Mr. Edgar then explained the map's legend and how the user can control what is showing on the app. A prominent feature of this bike-routing map will be the user's ability to "point and shoot" to select points on the map and have ArcGis route the optimal bike path. Users may also type in the directions for their route. Mr. Edgar then began his first example by zooming in to view the Metropolitan Branch Trail to show how a roadway connects to an off-street bike path. A user can then select multiple points to draw the desired route. This will create step-by-step directions for the user to click on. Clicking on a step will highlight the specific section of the route it refers to.

Stephen Finafrock, COG/TPB staff, reminded those in attendance that there used to be a bike routing system as part of the TDM Software. The new map in progress is introducing new technology and will be a vast improvement compared to the old bike-routing map.

Mr. Edgar then showed how the bike-routing system can seamlessly take users off a bike path and onto the street network. Mr. Edgar then showed that this bike-routing module may select the faster route over the bike trial. Users may click the route and drag it onto the bike path if they prefer.

Steven Osborn, COG/TPB Staff, gave an update to those in attendance regarding the status of the July 2017 TDM Resource Directory. The Resource Directory was currently in draft form. Mr. Osborn urged those in attendance to send any updates as they become available. Members do not have to wait for the update solicitation.

Mr. Osborn then reminded Committee members to note any transit-related updates that need to be included in the Directory.

Mr. Osborn reminded those in attendance that outreach effort will continue be made if no response is received by COG/TPB staff.

## 9. Quarterly Progress Reports

Stephen Finafrock, COG/TPB staff, discussed the FY2017 3<sup>rd</sup> quarter CCW Progress Report. Mr. Finafrock reviewed the report and encouraged those in attendance to view it and report any errors or changes to be made to <u>commutersupport@mwcog.org</u>.

Nancy Huggins, MTA, clarified that ARTMA is no longer part of this report and that their information needs to be displayed under Ann Arundel County. Mr. Finafrock agreed to make the change on the next progress report.
