Nina Albert, Real Estate and Parking Director, Washington Metropolitan Area Transit Authority Nina Albert is the Director of Real Estate and Parking at the Washington Metropolitan Area Transit Authority (WMATA), with responsibility for joint development and asset management. Prior to joining WMATA, Nina worked for Walmart, cultivating and managing strategic partnerships with community and other external stakeholders.

Ricky Barker, Planning and Zoning Director, Loudoun County

Ricky Barker is the Director of the Department of Planning and Zoning for Loudoun County, Virginia. Mr. Barker works closely with the Loudoun County Board of Supervisors, the Planning Commission and the public in the development of policies and plans that guide the use of land in the county. He previously served as Associate Planning Director in North Carolina.

Derick Berlage, Countywide Planning Chief, Prince George's County

Derick Berlage is a professional planner and land use attorney who has worked in several Maryland jurisdictions. He is currently the Chief of Countywide Planning for Prince George's County, where he is leading an effort to rewrite the zoning and subdivision ordinances. In addition to his work as a professional planner, he has practiced land use law with a national law firm, chaired a county planning commission and regional transportation planning board, and served three terms as an elected county council member in Maryland's largest jurisdiction, Montgomery County.
