





What is the CLRP?





Two Phase Approach to LRP Environmental Justice Analysis


Examine the Constrained Long-Range Transportation Plan for any disproportionately high and adverse impacts on low-income and minority populations.

Phase 1: Identification of concentrations of low-income and/or minority populations ("Equity Emphasis Areas").

Phase 2: Using the travel demand model, analyze the 2016 CLRP amendment using multiple accessibility and mobility measures.




Equity Emphasis Areas Process

What are Equity Emphasis Areas?

Criteria 1: Tract with concentration of low-income* greater than the 150% the region average.

Criteria 2: Tract with at least 150% concentration each of two or more minority groups.

OR


Very high concentration of one minority group AND low-income above the regional average.

*Low-income is defined as a household income less than 1.5 times the Federal poverty level, depending on size.










Interactive Demo: Low-Income






Interactive Demo: African American










