(FTA's) Job Access Reverse Commute (JARC) and New Freedom program funding for the Washington Urbanized Area. These funds are for improving mobility options of low-income commuters and persons with disabilities. The Human Services Transportation Coordination Task Force is responsible for the development of the region's Coordinated Human Services Transportation Plan and for overseeing the solicitation for JARC and New Freedom projects. The Technical Committee will be briefed on the CY 2013 solicitation which was conducted from February 7 through April 17, and on the status of the competitive selection process. At the June 19 meeting, the TPB will be asked to approve the selected projects for funding.
