### **District of Columbia**

- B24-0420 Clean Energy DC Building Code Amendment Act of 2021
  - Requires all new construction be subject to the District's voluntary net zero energy standard.
- B24-0267- Climate Commitment Act of 2021
  - Codifies the 2050 carbon neutrality commitment, adds interim targets for greenhouse gas reductions between 2025 and 2050.



# **Maryland and Virginia**

- In 2022, CEEPC's Legislative Subcommittee:
  - Opposed legislation that aimed to repeal the Regional Greenhouse Gas Initiative (RGGI)
  - Supported efforts to strengthen GHG emissions standards, building code standards, etc.
  - Supported initiatives to expand electrification of fleets and building electrification
  - Supported expansion of green financing mechanisms (i.e. Green Banks) and grant programs/funding aimed at resiliency and sustainability
  - Supported Community Solar initiatives and other renewable energy deployment initiatives



## Legislature Timeline

- Virginia
  - Session convenes January 11. 30-day session. Adjournment date is February 25.
- Maryland
  - Session convenes January 11. 90-day session. Adjournment date is April 10.
- D.C.
  - 2-year session 2023-24.
