Final Rule - Transit Agency Safety Plans

- Final rule is capstone for the collection of rules covering the Public Transportation Safety Program
 - The rule became effective on July 19, 2019. Applicable transit operators are required to certify their safety plan by July 20, 2020
 - The rule requires applicable transit operators to develop Public Transportation Agency Safety Plans (PTASP), which include the process and procedures for implementing Safety Management Systems (SMS)
 - The rule requires applicable transit operators to set Transit Safety targets



Transit Safety Performance Measures

	Performance Measures
Fatalities	Total number of reportable fatalities and the rate per total vehicle revenue miles by mode
Injuries	Total number of reportable injuries and the rate per total vehicle revenue miles by mode
Safety Events*	Total number of reportable events and the rate per total vehicle revenue miles by mode
System Reliability	Mean distance between major mechanical failures by mode

- Transit operators must establish transit safety targets by July 2020
- After the date of establishment MPOs have 180 days to set regional targets

*Collisions, derailments, fires, or life safety evacuations




Transit Agency Safety Plan rule applies to...

- All public transportation operators whom are either <u>recipients</u> or <u>sub-recipients</u> of FTA grant funds (5307)
- Agencies that operate more than 100 vehicles in peak revenue service (i.e., Tier 1)
- Operators of transit modes subject to the safety jurisdiction of another federal agency are exempt (i.e. Federal Railroad Administration (FRA) regulated = commuter rail: VRE and MARC)
- The final rule does not apply to public transportation operators that receive only 5310 and 5311 funds





FTA Guidance



 All public transportation operators whom are either recipients or subrecipients of FTA grant funds (5307)

Next Steps

- **Timeline**. Applicable transit providers must implement the rule and set safety targets by July 20, 2020
 - TPB will have 180 days to set regional targets, likely December 2020.
- Validate applicability and intentions. Collect information from regional agencies on whether they will be setting, targets, joining State Group plan, or are not affected
- After initial target-setting the process will occur on an annual basis



Other Transit Safety Rules

- National Public Transportation Safety Plan
 - Guides the national effort in managing the safety risks and safety hazards within our nation's public transportation systems
- State Safety Oversight Program (SSO)
 - Oversee safety at rail transit systems (i.e. MSC for WMATA)
- National Public Transportation Certification Training Program
 - For fed/state employees who conduct audits and examinations of public transportation systems
- Public Transportation Agency Safety Plans
 - Include documented processes and procedures for transit agencies' safety management systems, setting of performance targets
