SUBJECT: Supporting Questions 33.a. and 34.d. of the Project Input Solicitation Form - Location of projects to Equity Emphasis Areas and connecting to Activity Centers
DATE: November 25, 2020

There are new questions in the Project Input Solicitation Form for Visualize 2045 and the Transportation Improvement Program that members must answer related to equity: Question 33.a. and 34.d. Staff prepared a standard methodology to use to assist members when answering these questions. This recommended method does not have to be used; however, staff performed the analysis on the existing projects in the database presented on page 3 of this memo. The process outlined provides regional-level findings on how well the projects in Visualize 2045 may serve low-income and minority populations in the region. More than sixty percent of project records in Visualize 2045 are within or intersect TPB's Equity Emphasis Areas and more than fifty percent also intersect with COG's Activity Centers. Below is information on objectives, deliverables, and the methodological approach staff used and are recommending for members to consider using.

OBJECTIVES

1. Inform members so they better understand to what degree the existing constrained element of the plan has projects located in close proximity to TPB's Equity Emphasis Areas (EEAs)
2. Apply a standard methodology for members to use when completing their 2022 Update to Visualize 2045 project description forms
3. Pilot a method and process for staff to implement as part of a larger effort to consider equity for the 2022 update to Visualize 2045

DELIVERABLES

1. This summary memo and project tables (by agency, project id, and project name) on page 3 provides results of the methods described below.
2. Table and project layers presenting all project records and if they are identified as close to EEAs and connecting EEAs to Activity Centers.

METHODS FOR QUESTIONS 33.A. AND 34.D.

33. Equity Emphasis Area

a. Is this project physically in an Equity Emphasis Area (EEA)?

Step 1: Create layer applying a ½ mile dissolved buffer to TPB’s tract-level EEAs.

Step 2: Select Visualize 2045 Major Projects and Additional Projects lines and points that intersect the ½ mile dissolved buffer EEA layer.

Step 3: Conduct a record-by record review and adjust results, as needed.

Step 4: Record results, export, and package all records by Agency Name and Project ID.

34. Activity Centers

d. Does this project connect an Equity Emphasis Area to an Activity Center?

Step 1: Using the projects identified in question 33.a. as being in EEAs, selects those that also intersect COG Activity Centers by TPB TAZ boundary with a ½ mile dissolved buffer.

Step 2: Conduct a record-by record staff review and adjust results, as needed.

Step 3: Record results, export, and package all records by Agency Name and Project ID.

PRELIMINARY RESULTS

Using the methodology identified above, more than sixty percent of project records in Visualize 2045 are within or intersect TPB’s Equity Emphasis Areas and more than fifty percent also intersect with COG’s Activity Centers. The table below further details the proximity of various transportation modes and project types to EEAs and Activity Centers.
