State Laws

- Maryland: manufacturers of computers and televisions are required to
 - Offer a free take back service for recycling
 - Or pay annually into a state fund to that supports local government recycling events
 - Law updated in 2007 to include televisions







State Laws

• Virginia

- Two laws passed in 2008 session
- Manufacturers of computers must offer a free recycling program by July 2009 for residents; does not apply to televisions.
- Municipalities can ban CRT devices, including televisions, from disposal if there is a recycling program in place.





National Laws

- Fourteen other states have laws governing electronics recycling in various forms, the majority cover televisions
- There is no national requirement for the recycling of electronics or its funding
- National dialog is ongoing in government and industry





Private Initiatives

- Manufacturer take back programs
 - Sony, Dell, others
 - May be free or a cost
- Retailer drop off programs
 - Office Depot, others
 - Sometimes a fee
- Recycling Companies
 - Some allow drop off for residents, costs vary
 - Collect from businesses





Local Government Initiatives

- Single-Day electronics collection events
 - Held 2-5 times a year
 - Often combined with household hazardous waste and other collections
 - Frequently at temporary site like a school parking lot
 - Sometimes a fee for monitors and televisions
 - Often restricted to residents of the jurisdiction





Local Government Initiatives

- Permanent electronics collection sites
 - Hosted at a government facility
 - Usually open weekly or monthly
 - Ability to store material until a contractor can collect it
 - Sometimes a fee for monitors and televisions
 - Often restricted to residents of the jurisdiction

Televisions

• The DTV transition raises several issues:

- Some at risk groups may be harder to educate about how the switch affects them
- No one is certain if there will be a large spike in television disposal and recycling in the next year
- Local governments are in many cases funding television recycling on their own
- Programs for recycling televisions vary greatly in the region.





Resolution

- Resolution R26-08
 - COG to join the Digital Television Transition Coalition to allow greater access to resources and information to assist in educating the region on the 2009 transition;
 - Explore the possibility of federal legislation to direct some of the proceeds from the sale of the analog television bandwidth towards the cost of recycling televisions borne by local governments;







Resolution

- Resolution R26-08
 - Explore the potential for public-private partnerships as a mechanism for implementing digital television recycling programs in the region;
 - Continue updates to the Metropolitan Washington Council of Governments GoRecycle.org Web site and 1-877-GoRecyle phone line to educate consumers about recycling and to direct them to information resources.
