During the months of August and September, members of the Cooperative Forecasting and Data Subcommittee began submitting employment, population, and household forecast control totals to COG staff for submission for Round 7.2. During their October 7 meeting, the Cooperative Forecasting Subcommittee approved the new draft forecasts and noted the jurisdictional changes in the projections which included forecasts to 2040. Subcommittee Chair Rosenbaum and COG staff will brief the Planning Directors on the new Forecasts. The Metropolitan Development Policy Committee will act on the Round 7.2 Forecasts during their meeting on November 12.

Briefing on Montgomery County Centers and Boulevards Concept for Revitalization

In 2006, the Maryland National Capital Planning Commission released the draft report "Revitalizing Centers, Reshaping Boulevards and Creating Great Public Spaces". The intent of the county-wide planning effort was to examine the County's commercial centers and major arterial roads, with the goal of renovating them into vibrant community centers located along grand boulevards, with attractive public spaces, and accessible from surrounding neighborhoods on foot or bike and connected to each other by public transport. Mr. Carter will brief the Committee on this effort and how it relates to current master plan updates and a new zoning tool in the County.

Proposed Approach for Developing "Version 1" of the CLRP Aspirations Scenario

In September, the PDTAC received a briefing from TPB staff regarding the development of the Aspiration Scenario. At the direction of the TPB Scenario Task Force, the Planning Directors are being asked to comment on the proposed CLRP Aspiration Scenario. TPB staff prepared a series of spreadsheets and maps at the jurisdictional level detailing the shift in households and employment at the TAZ level for the scenario.

COG monitors trends in the region's economy and reports the trends monthly and in an annual summary report to the Board. COG staff will report the key findings in the report *Economic Trends in Metropolitan Washington*, 2003 – 2007. The report presents key regional economic indicators, including population growth, employment, federal spending, construction activity, housing sales, income, retail sales, and the number of passengers at the region's three major airports. In addition, COG staff will provide additional information on commercial construction from the *Commercial Construction Indicators* – 2007 Summary Report. This report provides information on the level of commercial construction activity by jurisdiction, structure type, and relationship to Metrorail, commuter rail stations and COG's Regional Activity Centers.
