### 10:30 A.M. 2. SHAPING FUTURE LAND USE AND TRANSPORTATION DECISIONS

Since January, COG's Planning Directors Technical Advisory Committee (PDTAC) has held discussions on the 7 endorsed initiatives of the Transportation Planning Board (TPB) Long-Range Plan Task Force (LRPT). The Committee has focused on the "Optimize Regional Land-Use Balance" initiative which calls for an additional 130,000 households by 2040 beyond those currently projected in COG's Round 9.1 Cooperative Forecasts.

PDTAC Chair Eric Shaw will share highlights from a draft July 18<sup>th</sup> presentation to the TPB (of which he is a member) which summarizes current local efforts to achieve the TPB Initiative, and lead us in discussing critical questions for our region's future, such as:

- How can HDAC and PDTAC work together through the end of the calendar year to provide substantive guidance to shape long-term transportation planning?
- How can we reach our goal to accommodate 780,000 households by 2045?
- How can we work together to ensure future growth is sustainable, location efficient, and equitable?
