


### **CPRG Overview**

- •The Climate Pollution Reduction Grants (CPRG) program provides grants to States, regions, and local governments to develop and implement plans for reducing greenhouse gas emissions and other harmful air pollution.
- •Section 60114 of the Inflation Reduction Act provides an investment of \$5 billion to support these efforts.
- •This two-staged grant program provides funding of \$250 million for noncompetitive planning grants, and \$4.6 billion for competitive implementation grants.
- •Non-competitive allocations include States, District of Columbia, Puerto Rico: \$3 million; Metropolitan Statistical Areas (MSAs): \$1 million each.
- •COG, via DC's allocation, is managing \$1 million for MSA climate planning, which includes communities from VA and WV.





### **CPRG Implementation Grant Awards**

- 25 awards for \$4.3B to fund state, local, and Tribal entities located in 30 states
- NJ, MD, CT, DE Coalition (\$250M): The Clean Corridor Coalition: A Proposal for ZE-MHDV Infrastructure Along the I-95 Corridor project will deploy electric vehicle charging infrastructure for commercial zero-emission medium- and heavy-duty vehicles on the Interstate-95 freight corridor as a joint venture among New Jersey, Connecticut, Delaware, and Maryland. The selected application will provide technical assistance for workforce development and corridor planning.
- NC, SC, MD, VA (\$420M): The Atlantic Conservation Coalition is a regional approach focused on natural climate solutions to reduce greenhouse gas emissions. The selected application will fund efforts to leverage the carbon sequestration power of natural and working lands, including coastal wetlands, peatlands, forests, and urban forestry.
- VA (\$100M): The Priority Methane Reduction Projects in Virginia grant will assist in the reduction of methane emissions by establishing a competitive grant program for projects at coal mines and landfills.
   The selected application will fund a competitive grant program for food rescue and composting programs at agencies, colleges, and universities.



### **CCAP** Requirements

- Updating GHG inventories and projections.

- Understanding pathways to achieve or exceed COG's GHG reduction goals.
- Developing more robust implementation information.
- Conducting more extensive analytics.
- •Re-engaging with existing stakeholders and expanding reach.
