COMMITTEE WORK FEATURE OUTREACH CALENDAR MEDIA

NATIONAL CAPITAL REGION TRANSPORTATION PLANNING BOARD (TPB)

At its monthly meeting, the TPB approved funding for eight technical assistance projects totaling \$420,000 through the Transportation Land-Use Connections Program (TLC)—a TPB program that helps local jurisdictions integrate land-use and transportation planning at the community level.

METROPOLITAN WASHINGTON AIR QUALITY COMMITTEE (MWAQC)

MWAQC was updated on the revised 1997 fine particle pollution maintenance plan. The region is in compliance with the fine particulate air quality standard, but needs to continue to control these emissions to further protect public health. MWAQC also received a briefing on the Multi-Sector Work-Group effort, reviewed outlines for an environmental justice tool-kit, and adopted the FY 2017 MWAQC Work Program.

HUMAN SERVICES AND PUBLIC SAFETY POLICY COMMITTEE (HSPSPC)

HSPSPC members were briefed on the results of COG's 16th enumeration of persons experiencing homelessness in the region. The group considered how the region can better respond to and meet the unique needs of veterans, youth, and LGBTQ youth experiencing homelessness.

CLIMATE, ENERGY, AND ENVIRONMENT POLICY COMMITTEE (CEEPC)

In May, CEEPC discussed the results of a COG-commissioned regional renewable energy study, which found that the region exceeded its 2016 goal to have at least 10 percent of electricity use come from renewable power; with the right policy and market drivers these levels could more than double by 2022. The group also kicked off the process for updating the 2017-2020 *Regional Climate and Energy Action Plan*, which will be adopted by the end of the year.

CHESAPEAKE BAY AND WATER RESOURCES POLICY COMMITTEE (CBPC)

With Chesapeake Bay Awareness Week coming up June 4-12, the CBPC endorsed an outreach plan at its May meeting to celebrate water recognition events (per COG Resolution 22-2016) this year and beyond. The plan emphasizes the region's effectiveness in protecting water quality and public health, and highlighting wastewater treatment plant success stories, stormwater innovation, and career paths in the water workforce.

The conference was held in partnership with Joint Force Headquarters National Capital Region (JFHQ-NCR) Chaplains and Public Safety Chaplains in the region.

COG's Corrections Chiefs Committee sponsored the 25th Annual Wreath Laying Ceremony in honor of fallen corrections officers. Speakers included COG Board of Directors Chairman Roger Berliner, Fairfax Sheriff Stacey Kincaid, and Dr. Thomas Kane, Director of the Federal Bureau of Prisons.

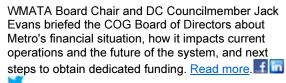

ADOPTION OF CONSENT AGENDA ITEMS

A. Resolution R28-2016 – Resolution authorizing COG to continue a contract to address findings of a Metro Public Safety Communications Interoperability Study

The board will be asked to adopt Resolution R28-2016 authorizing the Executive Director, or his designee, to receive and expend grant funds from the District of Columbia Homeland Security and Emergency Management Agency (HSEMA) in the amount of \$75,000. COG has been requested by HSEMA to continue a contract to assist the region in addressing findings in a comprehensive study of the Washington Metropolitan Area Transit Authority (WMATA) underground communications system. Funding for this effort will be provided through a subgrant from the State Administrative Agent for the National Capital Region. No COG matching funds are required.

RECOMMENDED ACTION: Adopt Resolution R28-2016.

B. Resolution R29-2016 - Resolution authorizing COG to continue the contract to provide programmatic support to the Securing the Cities Program for DC HSEMA

The board will be asked to adopt Resolution R29-2016 authorizing the Executive Director, or his designee, to receive and expend grant funds from the District of Columbia Homeland Security and Emergency Management Agency (HSEMA) in the amount of \$97,242. COG has been requested by HSEMA to continue programmatic support to the Securing the Cities (STC) Program that includes two full-time positions through August 31, 2016. Metropolitan Washington Council of Governments Five-Year Capital Expenditure Plan for FY2017 – FY2021

SUMMARY NARRATIVE

Introduction

Board Resolution R25-2016 established a Board-Designated Capital Expenditure Reserve to ensure adequate resources for replacement and maintenance of COG's capital assets. Use of the reserve requires approval by the Board of Directors, based on an annual Five-Year Capital Expenditure Plan submitted by the Executive Director through the Budget and Finance Committee.

Approval of the Five-Year Capital Expenditure Plan for FY2017 – FY2021 will authorize use of the Board-Designated Capital Expenditure Reserve for the FY2017 expenditures outlined in the Plan. Expenditures outlined in FY2018 – FY2021 are subject to further review and modification, and are not authorized until the annual budget for each of those years is adopted by the Board of Directors.

Definition of "Capital Expenditure"

COG's administrative policies define a capital expenditure as a tangible or intangible asset used in operations, with a cost exceeding \$5,000 and a useful life of more than one year, that can be capitalized in accordance with applicable accounting principles. COG has two categories of capital expenditures:

- 1. Equipment, Software, Data Center, and Website
- 2. Leasehold Improvements

Five-Year Capital Expenditure Plan FY2017 - FY2021

The Five-Year Capital Expenditure Plan is based on repair, maintenance, and replacement schedules developed with the following goals:

- Maintain existing equipment and software that support program and administrative needs
- Maintain COG's website as a source of information for stakeholders
- Maintain existing office and meeting space to ensure usefulness
- Prevent a backlog of deferred maintenance
- Minimize the fluctuation of annual depreciation expense in the Work Program and Budget
- Ensure adequate cash resources for both capital expenditures and operations

Proposed expenditures over the next five fiscal years total \$5.9 million, with \$1.5 million scheduled for FY2017. The balance in the Board-Designated Capital Expenditure Reserve is forecast to have sufficient resources for these expenditures, assuming continuation of annual revenue increases in the range of 3.0 to 3.8 percent.

The plan for FY2017 – FY2021 addresses deferred maintenance of COG office space, much of which has not been updated since occupying the building in 1989, including network cabling and audiovisual infrastructure. Once initial upgrades have been completed, it is anticipated that subsequent upgrades will be accomplished in phases, rather than with a major expenditure every twenty-five years.

Approval of FY2017 Capital Expenditures

Approval of the plan will authorize expenditure of \$1,397,500 in FY2017 from the Capital Expenditure Reserve for leasehold improvements, to include:

- o Architect and permitting costs related to work that will continue in FY2018 and FY2019
- o Replacement of network cabling, ceiling grids, and outdated lighting fixtures
- o Improved audio visual resources in COG's nine conference and meeting rooms

Approval of the plan will also authorize expenditures of \$81,600 in FY2017 from the Capital Expenditure Reserve for IT network and security upgrades, and the scheduled replacement of ten network printers.

Approval of the plan does not authorize expenditures outlined for FY2018 – FY2021. Capital expenditures for these years are provided for purposes of long-term planning, and will be reviewed, modified, and presented to the Board of Directors for approval with subsequent annual Five-Year Capital Expenditure Plans.

Impact on the Work Program and Budget in FY2017 - FY2021

Capital expenditures affect the amount of depreciation expense in the annual Work Program and Budget, and thus, the amount of surplus or deficit from operations at the end of each fiscal year. Based on the current fiscal forecast, COG will be able to fully implement the five-year plan and address current deferred maintenance by using undesignated net assets to cover planned deficits averaging 1% each year over the next three years, with a plan for steadily increasing the bottom line to realize a net surplus by FY2021.

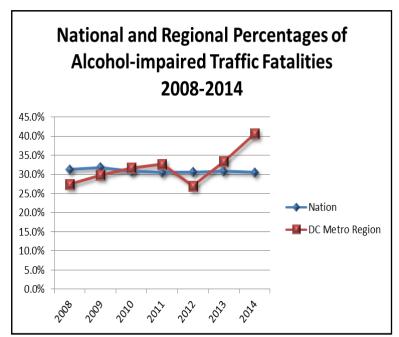

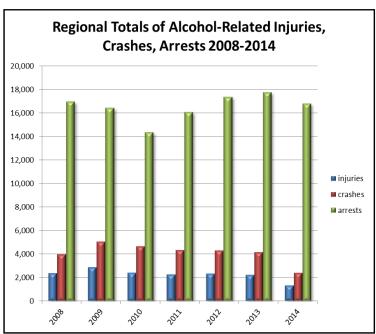


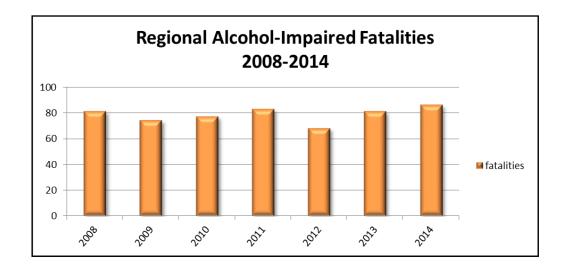




A Look at Regional and National Figures







The Metropolitan Washington Region has experienced a slight decrease in alcohol related traffic arrests and an increase in alcohol related fatalities. Final data is not yet available for alcohol related traffic crashes and injuries for this preliminary report.

Regional alcohol impaired traffic fatalities have increased to 40.5% of total crash fatalities in the region, compared with 33.3% due to alcohol-impairment in 2013. Nationally, alcohol-impaired fatality rates stand at 31%.





How Safe Are Our Roads? 2015 Overview

Findings in the 2015 preliminary report include:

FATALITIES: Local alcohol and/or drug-impaired traffic fatalities **increased** by 6.17% between 2013-2014 (from 81 to 86 such fatalities).

CRASHES: The final report will include crash data for the region and its changes between 2013 and 2014.

INJURIES: The final report will include injury data for the region and its changes between 2013 and 2014.

ARRESTS: Local arrests for either driving under the influence (DUI) or driving while intoxicated (DWI) **decreased** by 5.63% between 2013-2014 (from 17,724 to 16,779 such arrests).

Of the Washington Metropolitan area's 202 total traffic fatalities for 2014, **82 or 40.5%** of these roadway deaths were due to drivers who were alcohol and/or drug-impaired (BAC = .08+). National park data for the region is not included in these numbers.

National statistics (National Highway Traffic Safety Administration, NHTSA) show that 31% of total U.S. vehicular fatalities in 2014 were reported as alcohol impaired (BAC = .08+).

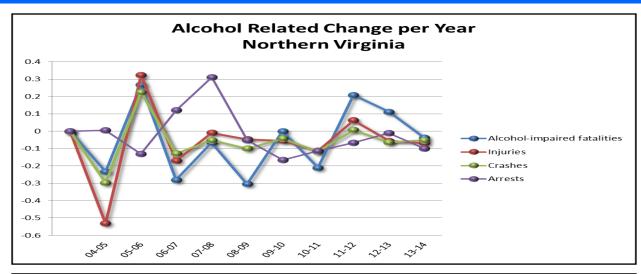
Data compiled in this report comes from national, state, and local sources including the U.S. Census Bureau, National Highway Traffic Safety Administration (NHTSA), Virginia Department of Motor Vehicles, Maryland National Study Center for Trauma and Emergency Medical Systems, and local police departments of each jurisdiction.

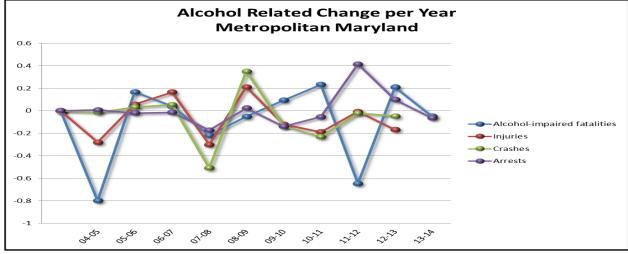
Parts of this report do not include National Park Police. District of Columbia, and Prince George's County data. Jurisdictional data in this report does not always include State Police data. The State Police in Maryland and Virginia are charged with enforcing traffic laws on state highways and interstate expressways; inclusion of this data would likely increase the number of incidents in all categories. It is possible that some jurisdictional data may include State Police figures because local police often respond to highway incidents when State Police are unavailable. In some jurisdictions, the data reported were provided by the state, and most likely include state police data.

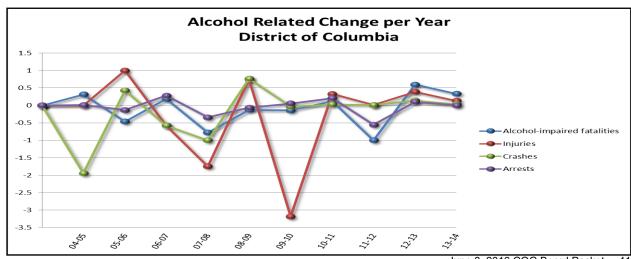




Sub-regional Trends

Definitions of Data-Related Terms

NHTSA Alcohol-Impaired Driving Traffic Fatalities: any fatality that occurs in motor vehicle traffic crash that involves at least one driver or a motorcycle rider (operator) with a BAC of .08 grams per deciliter or higher; This threshold does not consider the impairment status of non-occupants involved in fatal crashes, such as pedestrians or pedal cyclist.

WRAP Alcohol-Impaired Driving Traffic Fatalities: Any person who dies as result of a traffic crash involving alcohol with a BAC level .08 or higher

WRAP Alcohol-Related Traffic Fatalities for Persons Under 21: Any person under the age of 21 year who has died as result of an alcohol-related traffic crash involving a driver with a BAC level .01 or higher. This includes drivers, passengers, bicyclists, and pedestrians.

Alcohol-Related Traffic Injuries: where any driver, passenger, bicyclist or pedestrian is listed on the police report to be injured in an alcohol-related crash where the BAC = .01 or higher

Alcohol-Related Traffic Injuries for Persons Under 21: any person under the age of 21 who receives injuries because of an alcohol-related crash where the BAC = .01 or higher; this includes drivers, passengers, bicyclists, and pedestrians.

Alcohol-Related Traffic Crashes: the driver, passenger, bicyclist, or pedestrian is listed on the police report as drinking before the crash with a BAC = .01 or higher. At least one driver in the crash was reported to be under the influence of alcohol and/or other drugs.

Alcohol-Related Traffic Crashes for Persons Under 21: any person under the age of 21 who was involved in a traffic crash involving a driver with a BAC = .01 or higher. This data includes drivers, passengers, bicyclists, and pedestrians.

Drunk Driving Arrests/Citation: a general reference to those criminal cases that are called DUI, DWI, OUI, OWI or other acronyms that generally describe three types of cases:

-The driver is sufficiently impaired by alcohol, drugs or a combination of the two, and cannot drive safely, and has a BAC level of .01 or higher;

-The driver is a "Drunk Driver", as defined by the driver being above that state's legal limit of BAC .08;

-A driver under the age of 21 is under the influence of alcohol at a BAC level of .02 or higher

DWI/DUI Arrests: a driver is listed on the police report as arrested for operating a motor vehicle under the influence of alcohol with a BAC level of .01 or higher DWI/DUI Arrests for persons under 21: any person/driver under the age of 21 listed on the police report as arrested for operating a motor vehicle under the influence of alcohol with a BAC level of .01 or higher

Data Analysis

The findings in this report are based on data collected from organizations and agencies from across the Washington Metro region. Data tables provide totals within the Washington Metro region as well as individual jurisdictions. Analysis focuses on changes in motor vehicle fatalities, injuries, crashes, and arrests. Results are reported as numbers and percentage of alcohol-related incidents to total numbers across time.

Data Limitations

It is important to note limitations that affected collection and analysis of this data, as they may limit comparability across jurisdictions and influence the level of reasonable analysis. Whenever possible, limitations are noted within the tables and figures.

It should be noted that the researchers constructing this report utilized data from the National Study Center for Trauma and EMS (NSC) at the University of Maryland, for data pertaining to crashes, injuries, and arrests. Regarding the alcohol-related crash and injury data, the variable identifies a driver or pedestrian under the influence of alcohol, drugs, both, or none. Within the NSC data reported, researchers analyzed drivers reported as under the influence of alcohol or both, to capture alcohol-related

crashes and injuries. That variable is created using several others on the report (such as driver condition, BAC, etc.) so it does not specify only those with BAC 0.01+, and comparisons to previous year's data should be made with caution. In addition, because this report tracks just two jurisdictions in Maryland, regional totals could also be affected.

Additionally, there is no standardization for data definitions, collection, or recording within the Washington Metro region. Each agency has its own system of data collection, coding, and management. In addition, the range and type of data collected may not be consistent across jurisdictions. The data reported and analyzed in this report reflect data as reported by contact agencies. Independent verification of data to ensure accuracy is not within the scope of this report.

Information on data collection and management systems and changes within jurisdictions was not solicited. In addition, changes in laws or judicial priorities may result in increased attention to specific data (e.g. blood alcohol level in driver fatalities related to stricter server laws). In some cases, this may result in missing data or data that appears inconsistent when examined against the same values for previous years. It is beyond the scope of this report to identify data methodology or priority changes for each jurisdiction.

Data on alcohol-related driver involvement in motor vehicle fatalities, injuries, crashes and arrests was requested for alcohol-related (BAC= .01+) only, however, due to differences between jurisdictions in reporting on impaired data, some cases may involve drug use.

The number of incidents, total and related to alcohol impairment, is very small for some jurisdictions. Due to the small numbers, jurisdictional analysis might easily misrepresent the problem. For example, an increase of one alcohol-related fatality would have little impact in a jurisdiction that saw 50 alcohol-related fatalities the previous year, but would appear to represent a significant change in a small jurisdiction with only one or two alcohol-related fatalities the previous year.

Data are reported and analyzed by absolute numbers only. At this time, information that would allow identification of comparable rates is unavailable. It is assumed that people involved in motor vehicle crashes and arrests may live within or outside the Washington Metro region. Collection of data on driver or passenger residence versus jurisdiction of accident is beyond the scope of this report. Calculating rates based on the Washington Metro region's population or number of licensed drivers would not accurately represent the problem since drivers may be from outside the jurisdiction.

Data on people under the age of 21 years is collected in an inconsistent manner among jurisdictions. Caution must be used in evaluation of this data due to varied definitions and missing data.

Many charts display two regional total numbers. The first, "DC Regional Total" is the total of the District of Columbia, the Maryland Region, and the Northern Virginia Region. The second regional number, "Regional Total Adjusted" includes data from the United States Park Police. Because the Park Police information has only been recently collected, it is shown separately and the two regional totals are shown so that comparisons with previous years can be done.

The board approves the report, "How Safe are our Roads?" and encourages COG Board members and the Executive Director to share this data with public safety officers throughout the 22 COG member jurisdictions in an effort to reduce drunk driving throughout the region.

RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR TO CONVENE A TECHNICAL PANEL TO PREPARE A METRORAIL SAFETY, RELIABILITY AND STATE OF GOOD REPAIR NEEDS AND REVENUE **ASSESSMENT**

WHEREAS, the Metro rail system is the most significant regional transportation system and plays a critical role in meeting the National Capital Region's socio-economic and mobility needs and has served this need for the past 40 years; and

WHEREAS, a series of recent events including the January 12, 2015 L'Enfant Plaza smoke incident, subsequent smoke, fire and other disruptive events in 2015 and 2016 have undermined Metrorail's reliability and strongly reinforce the urgent need to restore the safety of the aging Metrorail system; and

WHEREAS, these recurring issues led to a 29 hour complete shutdown of the system in March of this year and the region is now faced with an extended period of safety-related repair and maintenance work activities called SafeTrack, which is anticipated to cause significant inconvenience and disruption of socio-economic activities in the region; and

WHEREAS, on March 30, 2016 COG in partnership with the Greater Washington Board of Trade held a summit of the regional elected and business leaders to discuss the importance of restoring Metro rail to a World Class System by addressing the safety and service reliability challenges the system is facing at present; and

WHEREAS, the region's leaders are unified in their desire to help the Washington Metropolitan Area Transit Authority address the safety and service reliability issues faced by its Metro rail system; and

WHEREAS, the current safety and service reliability issues of Metro are partly due to the funding constraints it faces; and

WHEREAS, on January 6, 2005, COG, the Greater Washington Board of Trade and the Federal City Council issued "The Report of the Metro Funding Panel", and

WHEREAS, the 2005 report examined and documented Metrorail operating and capital funding needs for 2005-2015, and evaluated a range of financing alternatives for providing funding to meet the needs; and

WHEREAS, the 2005 report concluded that insuring safety, reliability, and state of good repair for the Metrorail system requires stable and predictable funding; and

WHEREAS, in 2008, the United States Congress adopted the Passenger Rail Investment and Improvement Act (PRIIA) which established an annual, ten year dedicated federal appropriation of \$150 million annually, matched by \$50 million each from the District of Columbia, Maryland and Virginia, and such funding has helped address some of the capital cost needs to bring Metrorail into a state of good repair identified in the 2005 study; and

WHEREAS, the current state of safety and service concerns associated with Metrorail and the resultant disruptions to mobility and commerce in the region reaffirms the need to thoroughly explore and address to the best of the region's ability the funding and revenue needs of the Metrorail system:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN **WASHINGTON COUNCIL OF GOVERNMENTS THAT:**

The Board authorizes the Executive Director to convene a Technical Panel of Chief Administrative Officers and Chief Financial Officers, who in partnership with the Washington Metropolitan Area Transit Authority Chief Financial Officer will:

- 1. Document current funding projections for:
 - a. Operating the current Metrorail system in a safe and reliable manner;
 - b. Fully implementing the Metrorail system's replacement/rehabilitation program.
- 2. Provide the Board with an interim report in September of this year; and
- 3. Explore potential sources for any additional revenue the region may need to meet the above safety and reliability funding needs of the Metrorail system, and
- 4. Resources to carry out the work of the Technical Panel shall be mainly provided by inkind contributions, however, the Executive Director is authorized to allocate additional resources to support this initiative drawn from the existing FY 2016 and FY 2017 approved work program and budget.
