A. Bay WIP/TMDL Schedule Updates

Mr. Bieber will go over the Bay TMDL schedule, highlighting revisions, and review preliminary Water Quality Model information regarding the Sediment TMDL and clarity/SAV responses in the Potomac. He will also seek WRTC recommendations for a letter, from the CBPC to EPA Region 3, voicing concerns about the revised schedule.

B. Watershed Model 5.3

Mr. Berger will review the issues that have been raised about Phase 5.3 of the watershed model and discuss their potential implications for WIP and TMDL development. He will also provide updates on several modeling assumptions and issues related to wastewater plant and CSO loads that will have implications for COG's members.

Action: The WRTC will be asked to recommend to the CBPC that a letter be written to Shawn Garvin, Regional Administrator, EPA Region 3, concerning the compressed Bay TMDL schedule. The proposed letter would ask for greater opportunities for local government and other stakeholder comment on the draft TMDLs and WIPs, for greater transparency and outside review of the Watershed Model and for EPA to more clearly outline how adaptive management will be used to address uncertainties in the model.

III. District of Columbia MS4 Permit Updates- Jeff Seltzer, DDOE

Mr. Seltzer will provide an overview of EPA's proposed MS4 permit for the District of Columbia, recently issued by EPA Region III. It and Montgomery County's would be among the strictest in the country.
