- CEEPC's Legislative Committee is a small group of CEEPC members who periodically meet with staff to review legislative initiatives in D.C., Maryland, and Virginia
- COG staff track various bills during the legislative session that fall within COG's legislative priorities
- A series of ad hoc calls are held to determine specific bills to send comment letters on
- The committee primarily runs from January – April

 - Adjournment: April 10
 - D.C.
 - 2-year session 2023-24

District of Columbia Legislation

- Electric Bicycle Incentive Kickstarting the Environment (“E-BIKE”) Act of 2023
- Electric Bicycle Rebate Program Amendment Act of 2023
- Healthy Homes and Residential Electrification Amendment Act of 2023
- Comprehensive Electric Vehicle Infrastructure Access, Readiness, and Sustainability Amendment Act of 2023
- Green New Deal For Housing Amendment Act of 2023

Virginia Legislation

- Virginia Clean Economy Act (VCEA)
 - A series of bills attempt to roll back climate progress by either weakening the VCEA itself or increasing Virginia's dependence on fossil fuels
- Clean Car Standards Repeal
 - 5 bills to repeal the Clean Car Standards were defeated by the Senate Agriculture, Conservation and Natural Resources Committee. One House bill passed. This bill was passed by indefinitely by the Senate.
- Electric Vehicle Infrastructure
- Clean Energy

Regional Greenhouse Gas Initiative (RGGI)

- State Air Board voted to withdraw from RGGI (Dec. 7, 2022)
 - Currently with Governor's Office, next will be a 60-day public comment period, back to Air Board
- Joint Commission on Administrative Rules voted 5-4 objecting to RGGI withdrawal (Dec. 20, 2022)
 - Objection will be filed with the Virginia Registrar and the State Air Pollution Control Board
- Legislation: SB 1001 (Stuart): Clean Energy and Community Flood Preparedness Act; Repeal.
 - Directs the Director of the VA Department of Environmental Quality to take all steps necessary to suspend the Commonwealth's participation in the RGGI. Passed by indefinitely in Senate Agriculture, Conservation and Natural Resources
