 SUBJECT: Appointment of Citizens Advisory Committee (CAC) members for 2013

I worked as a planner in Arlington County's Planning Office between 2000 and 2008 and am a Certified Planner with the American Institute of Certified Planners. In Arlington, I led a team that tracked demographics and development data, and was a participant in several planning efforts within the County including the Clarendon and Crystal City public processes. I learned a great deal during that time about the interface between land use and transportation including transit oriented development and smart growth objectives.

I have been an avid cyclist for many years and frequently commute via bicycle through the region's parks, on street routes and bike paths. As a parent of a young child (my son is nearly five), I have gained an interest in pedestrian issues – the need for sidewalks and linkages on the neighborhood scale that is often frequented by youngsters as they go from home to parks and neighborhood retail. I am an advocate for alternative commuting options and telework one day a week myself. Having worked professionally with the numbers of commuters and modal splits of various communities in our region, I understand the important role that alternative commuting can play as we accommodate employment growth with a constrained transportation network.

I also believe that roads are an important part of our transportation system. I ride Metro (rail) to work most days, but use roads a great deal for short trips to daycare or shopping and on longer trips to visit family. I am interested in helping the region make the best use of this important and expensive resource. Lastly, environmental stewardship is a personal core value. I now serve as the chair of the Department of Transportation's "Green Team". In this capacity, I help to coordinate environmental efforts among the various Department Agencies (rail, transit, highways, etc.) and encourage staff to take the lead in making the best use of resources.

I served as an Alternate to the TPB CAC for the 2012 year (February 2012 through January 2013).

I am active in transit issues in my neighborhood --- I live 5 houses from the future right of way of the Purple Line and have been involved in neighborhood meetings and testimony in favor of this LRT system.

I am currently president of Action Committee for Tranist, a 26 year old transit/safe-streets advocacy group in Montgomery County. My community work vis a vis promoting the feasibility of the Purple Line coming right through our neighborhood has given me a closeup view of neighbors fears about change, as well as the benefits to our immediate community & areas further away (Bethesda, Langley Park, UMD) and their needs for the Purple Line. I've attended many Planning Board hearings on the Purple Line, where the issues range from what advantages/challenges it will contribute to Silver Spring, Chevy Chase or the Long Branch area (lower income, minority businesses) neighborhoods. It is interesting to hear such diverse (and passionate!) perspectives.

Montgomery County is updating/streamlining its massive zoning code and, while not a member of the Advisory Group, I have been interested and attended many of the AG open meetings and briefings by the planning board staff. Streamlining the code and fostering easier approaches to attracting Transit-Oriented-Development, I believe, will make for more walkable communities --- something that both young people and people retiring-in-place are lobbying for. Hence I'd like to stay in touch with the regional issues in this regard, and the CAC/TPB is a wonderful vantage point to view what is happening to TOD throughout the region.

In my neighborhood, I am both a pedestrian and a bicyclist (I try to leave our one car in the garage as much as possible!). And I'm a member of WABA. Roads, we've been trained, are meant for cars. However, if we want more walkable communities, we're going to have to press hard to re-educate people that roads (and sidewalks) are for moving PEOPLE --- yes, cars use the roads, but so do buses and bicycles. Pedestrians need sidewalks and we need them wide enough for people pushing strollers and people in wheelchairs. This has been a "forgotten" aspect of road design, I believe, in our county and perhaps elsewhere as well. I'd like to continue on the CAC to press forward this idea that the road network is for ALL people, not just cars.

This past year I have had the honor to serve as CAC chair and have attended almost all the TPB meetings -- I appreciate having had this opportunity to participate and view the region's transportation issues, as opposed to just the local/county issues.

1. Why are you interested in serving on the TPB's Citizen Advisory Committee?

Metropolitan Planning Organizations have a unique role in coordinating regional transportation investments, and TPB is no exception. The Washington metropolitan area, faced with significant population growth over the next several decades, will face significant mobility challenges. At the same time, the DC metro area is one of the leaders in alternative transportation mode share, and it will become increasingly more important to rely on growing our transit, bicycle, and pedestrian networks as road capacity becomes increasingly more constrained.

I live and own a home in an inner suburb in Prince George's County (Mount Rainier), where I have lived for the past few years. Mount Rainier, which is over a hundred years old, parallels both one of the earliest Baltimore and Ohio railroad branches, as well as one of the former major streetcar lines. Last March, I participated in the Washington Metropolitan Council of Governments' Transportation Planning Board's Community Leadership Institute. I also am a Leadership Fairfax alum where I was involved in two class projects: one on Route 1 Corridor Revitalization and, the second, on Transportation – What are the priorities? I have a Master degree from the University of Virginia in Environmental and Urban Planning. Also, below is a summarized explanation on some of the other areas I know I could contribute to the Citizens Advisory Committee.

Affordable housing – I have been in real estate for the last 15 years and I am well aware of the scarcity of affordable housing in our area. It is a challenge to make affordable housing available in current developments. Of course, there are more applicants than homes available. As a real estate brokers, I offer first time home owners workshops to purchase their first property.

Business/Chamber – I am the President and founder of the Hispanic Chamber of Commerce of Northern Virginia. Transportation options allow prospective employee to reach employment creating a healthier economy. We concentrate on the Latino community and communities wanting to do business with Latinos in the area.

Motor Vehicle Advocacy – I do not think waging a war against car is the way to accomplish a good transportation plan. I think one of the reasons this country is efficient is due to many people being able to drive their own cars. Cars should be part of a transportation plan; especially in those areas where having public transportation is not cost effective.

Telework – This is another good option that should be included in transportation plans. I think its benefits definitely outweigh its cost. I allow my agents to work from home as much as possible.

Smart Growth – Stopping growth could only be accomplished by modifying some of our civil liberties. Population continues to increase and they need infrastructure, homes, services, etc. That is why I get involved in zoning hearings, HOA's and keeping with local decisions as much as possible.

Land-Use Issues – This is another major area that causes many of our current problems in Virginia. Previous state, county and local officials, trying to apace their residents, approved/made land use decisions that placed a strain on the local infrastructure. Making sure that land use makes sense and promotes in some areas higher density and less commuting should another component of a good transportation plan. My academic background in Planning allows to see options that can work better when planning communities.
