On May 21, 2012, EPA issued the final designation for the 2008 Ozone National Ambient Air Quality Standards (NAAQS), with the Washington Metropolitan Area designated as marginal nonattainment. This designation requires a new air quality conformity analysis of the Washington region's 2012 CLRP and FY 2013-2018 TIP that will include the region's new 2015 attainment year. The analysis must be completed before July 20, 2013. The Committee will be updated on the draft scope of work for the 2015 forecast year air quality conformity analysis of the 2012 CLRP and FY2013-2018 TIP. On September 13 the scope of work was released for a 30-day public comment period that will end on October 13. At the October 17 meeting, the TPB will be asked to approve the scope of work for the air quality conformity assessment.
