RE: Steering Committee Actions

At its meeting of February 5, 2010, the TPB Steering Committee approved the following resolutions:

- TPB SR16-2010 on an amendment to the FY2010-2015 Transportation Improvement Program (TIP) that is exempt from the Air Quality Conformity Requirement to add funding for the purchase of three hybrid/compressed natural gas buses for Arlington Transit, as requested by the Virginia Department of Transportation (VDOT).
- TPB SR17-2010 on an amendment to the FY2010-2015 Transportation Improvement Program (TIP) that is exempt from the Air Quality Conformity Requirement to add funding to reconfigure the interchange of I-295 and Malcolm X Avenue, as requested by the District Department of Transportation (DDOT).
- TPB SR18-2010 on an amendment to the FY2010-2015 Transportation Improvement Program (TIP) that is exempt from the Air Quality Conformity Requirement to add funding for the Ways To Work program, as requested by the Virginia Department of Transportation (VDOT).

The TPB Bylaws provide that the Steering Committee "shall have the full authority to approve non-regionally significant items, and in such cases it shall advise the TPB of its action."

Dear Chairman Snyder:

On behalf of Arlington County, VDOT's Northern Virginia District Office requests amending the FY 2010-2015 Transportation Improvement Program (TIP) to provide funding for a transit project. Part of the funding for this project comes from a Federal Transit Administration program called the Transit Investments for Greenhouse Gas and Energy Reduction (TIGGER) which is administered as part of the American Recovery and Reinvestment Act (ARRA - Federal stimulus).

Purchase of Buses for Arlington Transit (ARL-0018). The proposed amendment will add \$1.5 million in TIGGER grant funds to be used for the purchase of three (3) hybrid/compressed natural gas transit buses. In addition to the grant funds, Arlington County will be contributing \$0.48 million in local money to the project as a supplement (the grant does not require a local match), resulting in a overall project cost of \$1.98 Million dollars.

The new buses will be used to continue provision of existing bus services and will not, by themselves, result in initiating new transit services in the county. As such the project will not affect the currently approved air quality conformity analyses.

The attached table presents the revised project funding for the FY 2010-2015 TIP. Also attached is a copy of the letter of request from the Director of Transportation for Arlington County.

VDOT requests that this amendment be approved by the TPB's Steering Committee at its February 5, 2010 meeting. Upon approval of this amendment, please furnish copies of the approval to Ms. Jo Anne Sorenson (VDOT's Northern Virginia office) and to Mr. Chad Tucker in VDOT's Transportation and Mobility Planning Division in Richmond.

The District Department of Transportation (DDOT) requests an amendment to the FY 2010-2015 Transportation Improvement Program (TIP). The purpose of this amendment is to add one additional project, the Malcolm X Avenue/I295 Interchange reconfiguration, to the Saint Elizabeths Campuses Access Improvements project (TIP ID #5723) currently included in the FY 2010-2015 TIP. A copy of the TIP project listing is attached.

On December 4, 2009 the TPB Steering Committee approved Resolution TPB SR9-2010 to amend the FY 2010-2015 TIP to include the St. Elizabeths Campuses Access Improvements Project with the Sheppard Parkway Access Road improvement. The purpose of the Sheppard Parkway access road is to provide access to the St. Elizabeths West Campus gate on the west side of the site. The facility will connect Firth Sterling to Malcolm X Avenue. This access road will be utilized by Department of Homeland Security (DHS) employees in personal vehicles, DHS shuttles, and Metro Bus. This facility will be closed to the public. The facility will be open by 2013. Design work will begin in 2010. The project will be funded using \$ 42.5 million in federal earmark funds.

The purpose of the proposed Malcolm X Avenue/I295 Interchange reconfiguration is to provide the necessary connection with the access road and connect the campus to the interstate network. Sketch level planning is complete. Design work would commence in 2012, construction in 2013 and the facility would open by 2015.

Following are funding details for the Malcolm X Avenue/1295 Interchange reconfiguration:

- For FY 2012 \$10 million for design of the interchange (source: STP)
- For FY 2013 \$90 million for construction of the interchange (source: STP)

The proposed project does not require conformity analysis or public review and comment. The funding source has been identified, and the TIP will remain fiscally constrained. Therefore, DDOT requests that the TPB Steering Committee approve this amendment at its February 5th meeting. We appreciate your cooperation in this matter.

On behalf of the Northern Virginia Family Service (NVFS), VDOT's Northern Virginia District Office requests amending the FY 2010-2015 Transportation Improvement Program (TIP) to include a Federal Transit Administration "Job Access and Reverse Commute" (JARC) grant that NVFS has received. In 2009, Congress re-programmed a 2002 Virginia earmark in the amount of \$1 million for the "Ways to Work" (WtW) program in Virginia. Of that amount, \$250,000 has been assigned to NVFS to operate a WtW program in the Northern Virginia region. The program provides loans to low income families for car purchases to ensure transportation to jobs, thus improving economic stability. The WtW program is not a pilot program but an established program. Ways to Work, Inc., which is the national office of the WtW program, will be the recipient of the JARC funds. In order to access these assigned funds, Ways to Work, Inc., must certify to the FTA that the WtW loan program funds are included in the regional TIP. The proposed TIP entry is below.

Ways to Work Project. The proposed amendment will add \$0.5 million in FTA JARC grant funds to be used for the loans to low income families to purchase cars in order to have transportation to jobs. The funding consists of \$0.25 million in grant funds matched with \$0.25 million by the Ways to Work program.

The project will not affect the currently approved air quality conformity analyses.

The attached table presents the revised project funding for the FY 2010-2015 TIP. Also attached is a copy of the letter of request from the President and CEO of Northern Virginia Family Services which will manage the WtW program in Northern Virginia. VDOT requests that this amendment be approved by the TPB's Steering Committee at its February 5, 2010, meeting. Upon approval of this amendment, please furnish copies of the approval to Ms. Jo Anne Sorenson (VDOT's Northern Virginia office) and to Mr. Chad Tucker in VDOT's Transportation and Mobility Planning Division in Richmond.

As per our discussion with Beth Newman at the Metropolitan Washington Council of Governments, please consider our request to amend the Transportation Improvement Plan (TIP) to include Northern Virginia Family Service's Ways to Work project.

In 2009, Congress re-programmed a 2002 Virginia earmark in the amount of \$1 million for Ways to Work programs in Virginia. These funds are through the Job Access and Reverse Commute (JARC) program of the Federal Transit Administration. \$250,000 of the earmark has been assigned to Northern Virginia Family Service. The funding is for a three-year period and will be used to operate a WtW in the Northern Virginia region inclusive of the following counties; Arlington, Fairfax, Loudoun, Prince William and it the cities of Alexandria, Manassas, Manassas Park and Winchester.

The Ways to Work (WtW) program provides loans to low-income families for car purchases to ensure transportation to jobs, and subsequent economic stability. Loan recipients repay the loan over two years at a moderate interest rate, and then the money is made available to other applicants. Eligibility qualifications are stringent and repayment rates are strong. This is not a pilot program, but an established program with a documented record of success.

Ways to Work, Inc., the national office of the WtW program, is the primary recipient of the JARC funds. Ways to Work, Inc. is the sister organization of the Alliance for Children and Families and is supported by a wide variety of private and public partners, including the Bank of America, the McKnight Foundation, the United States Department of Treasury's Community Development Financial Institutions (CDFI) Fund, the John S. and James L. Knight Foundation, and many others.

In order to access these funds Ways to Work, Inc. must submit an application to the Federal Transit Administration. In this application, Ways to Work, Inc. must certify to the FTA that the loan program is included in the area Metropolitan Transportation Organization's (MPO) TIP.
