TPB ELECTS 2008 CHAIR AND

VICE-CHAIRS

n December 19 the Transportation Planning Board (TPB) elected District of Columbia Councilmember Phil Mendelson as chair for the 2008 calendar year. Councilmember Mendelson served as TPB chair in 2002 and 2005 and has championed a number of regional planning issues over the years, including emergency preparedness and air quality.

The TPB also elected Frederick County Commissioner Charles A. Jenkins as first vice-chair representing Maryland and City

TPB ADOPTS PARTICIPATION PLAN

The TPB has adopted a new Participation Plan that outlines public involvement activities for constituencies with different levels of understanding and interest in the TPB process.

"In our public outreach, we need to identify different kinds of constituencies, and tailor our activities and tools to these different groups," said John Swanson of the TPB staff prior to adoption of the Plan at the December 19 TPB meeting.

"On the one hand we have people who have been very involved in our process—people like the Citizens Advisory Committee—and we need to continue to support their involvement. But, on the other hand, we have community leaders and the general public—folks who may

actually never need to really get involved in the TPB, but still could benefit from some outreach from us. And we could benefit by getting some sense of what they're thinking and feeling about regional transportation and land use issues."

Swanson explained that the new Participation Plan, which was required by the 2005 federal transportation reauthorization legislation (SAFETEA-LU), gave the TPB the opportunity to integrate recent enhancements in the TPB's outreach efforts including a new website, leadership training activities and interactive forums on land-use and transportation scenarios.

The new plan calls for the TPB to be more

of Falls Church Council Member David F. Snyder as second vice-chair representing Virginia.

Chair Mendelson was first elected to the District of Columbia Council in November 1998. He is the Chairman of the Committee on Public Safety and the Judiciary and is a member of four additional committees: Health; Housing and Urban Affairs; Human Services; and Libraries, Parks, and Recreation. He also represents the District of Columbia on the Metropolitan Washington Air Quality Committee.

Active with District issues since 1975, Chair Mendelson joined the McLean Gardens Residents Association to save that 43-acre housing complex from destruction. He ran for a seat on the Advisory Neighborhood Commission in 1979 and continued to serve as an ANC Commissioner until he took office as an at-large member of the Council. He came to Washington from Cleveland, Ohio in 1970 to obtain a Bachelors degree in political science from The

American University.

Chair Mendelson is currently serving on the Board of Directors of the Association of Metropolitan Planning Organizations (AMPO), a national organization representing the interests of transportation planning agencies like the TPB. From his years of service on the TPB and AMPO, he has developed an unusually high level of expertise in regional planning issues, such as air quality conformity, and has been a strong advocate within the District of Columbia for regional cooperation.

First Vice-Chair Jenkins is a veteran of the United State Navy, having served four years as a Navy Cryptologist. During his tenure, he earned the Navy Achievement Medal and the Joint Services Achievement Medal. A 1990 graduate of James Madison University, he holds a Bachelor's degree in the Russian language with minors in history and Russian studies. He is a private pilot and member of the Aircraft Owners and Pilots Association. He currently serves as a Realtor for Re/Max 100.

Second Vice-Chair Snyder was first sworn in as a member of the Falls Church City Council in 1994. He has served as Mayor and Vice Mayor of the City of Falls Church, having been elected to four terms on the City Council, most recently in May 2006. From 2004 to 2006, he chaired the Northern Virginia Transportation Authority and continues to serve as a member of the Authority. He currently chairs the TPB's Management, Operations and Intelligent Transportation Systems Policy Task Force and will chair the Metropolitan Washington Air Quality Committee in 2008. He graduated Magna Cum Laude from Dickinson College and graduated from the George Washington University Law School. He is licensed to practice law in the District of Columbia, Pennsylvania, and Virginia.

TPB SCHEDULED TO APPROVE 2007 CLRP

In preparation for the scheduled approval of the longrange plan on January 16, the TPB on December 19 received an update on the contents of the plan and on the air quality analysis that TPB staff has conducted to ensure the plan is in conformity with regional air quality goals.

Four major new projects are scheduled to be included in the TPB's 2007 long-range plan, known as the Constrained Long-Range Transportation Plan (CLRP), and the FY 2008-2013 Transportation Improvement Program (TIP).

Among these projects is a major new HOT lanes (high occupancy/toll lanes) project on 36 miles of I-395/I-95 in Northern Virginia. The project will be the second HOT lanes facility approved for the region. In 2005, the CLRP was amended to include HOT lanes on 15 miles of the Capital Beltway in Virginia.

The HOT lanes project is not the only major Virginia project getting attention in this plan update. The Virginia Department of Transportation (VDOT) is also proposing to build "spot improvements" on I-66 inside the Beltway, which generated lively discussion at previous TPB meetings.

The TPB approves a new CLRP and TIP every year.

The CLRP includes all the major transportation projects that the region anticipates can be funded and built between now and 2030. The TIP is a six-year, more detailed subset of the CLRP. All regionally significant projects must be included in the CLRP and TIP in order to receive federal funding.

Call for Projects for 2008 CLRP

The TPB has issued a call for projects for the 2008 CLRP and FY 2009-2014 TIP. The deadline for project submissions is January 11, 2008. Projects are submitted by the region's local governments and transportation implementing agencies, including the state departments of transportation and the Washington Metropolitan Area Transit Authority (WMATA).

The TPB is expected to review a significantly increased slate of projects this year because new funding is available to the Northern Virginia Transportation Authority (NVTA). NVTA was created by the Virginia General Assembly in 2002 and is responsible for long range transportation planning in Northern Virginia. In April 2007 the Virginia General Assembly granted NVTA the authority to collect funding through taxes and fees. This is the first year NVTA will be submitting projects for inclusion in the CLRP and TIP. \blacktriangle

strategic in targeting its activities to serve the needs of three different levels of constituencies. The Participation Plan focuses on tailoring outreach and involvement activities to the "involved" public, the "informed" public and the "interested" public. These three categories represent a continuum in typical levels of interest and expertise, ranging from extremely active individuals like members of the Citizens Advisory Committee to members of the general public. This distinction addresses the realization that not all members of the public may know about the TPB, and that requirements for information about regional transportation planning may be different for each constituency.

The Participation Plan also articulates the overarching importance of public involvement in the decision-making process. "The TPB believes that public input into its process is valuable and makes its products better," the document states. "Regional transportation planning cannot and should not be based simply upon technical The qualitative information analysis. derived from citizen involvement is essential to good decision-making."

The TPB worked on the Participation Plan throughout 2007, receiving input from numerous stakeholder groups. Before the development of the Plan began, the TPB contracted the firm Circle Point to conduct an evaluation of its outreach activities. That consultant evaluation encouraged the TPB to be more strategic in devising its annual outreach program.

Now that the Participation Plan has been adopted, TPB staff will work with the TPB to develop an Annual Participation Program. This program will identify the participation activities to be conducted over the course of each fiscal year and define how the activities will enhance the ability for each constituency to participate in the TPB process.

The TPB will continue to provide comprehensive information to the "involved public," those who already know about and participate in the TPB process. The TPB can improve efforts to educate and empower the "informed public," those who may follow local and regional transportation planning issues. For the "interested public" who have limited knowledge about transportation planning, the TPB can simplify the regional transportation planning issues and provide those citizens with materials that are easy to access and understand.

FUNDING FOR VIRGINIA PROJECTS INCREASED

At its December 19 meeting, the TPB approved an amendment to the FY 2007-2012 Transportation Improvement Program (TIP) that increased funding to three components of the Virginia Department of Transportation (VDOT) Capital Beltway HOV/HOT Lanes project.

The TIP amendment increases funding for three components of the I-495 Capital Beltway High Occupancy/Toll (HOT) lanes Project: the Springfield Interchange (Phase VIII); the I-66 Access Improvements and Flyover Ramp; and the I-495 Capital Beltway widening to 12 lanes.

New funds were added to these components of the I-495 Capital Beltway HOV/HOT Lanes project to reflect new project costs resulting from financing and increased design-build costs. The I-495 Capital Beltway HOV/HOT Lanes project is now estimated to cost \$1.603 billion: \$157 million from the Virginia General Fund, \$1.1 billion in TIFIA private activity bond funds, and \$346 million from the private entity that will build and operate the HOT lanes. \$33.59 million in new funds were added to the I-66/I-495 interchange project. A new project listing was created for the non-HOT lanes portion of the Beltway HOV/HOT lanes project, to which \$55.15 million was added.

These changes in funding were necessary due to increased costs of construction materials, converting

funding to year-of-expenditure dollars, and finalized financing arrangements between VDOT, the Federal Highway Administration, and private partners.

"That amount of money is breathtaking, but this is an innovative project and it is the first change to the Beltway in terms of HOV or multi-use lanes that we've ever had."
