# Commuting to Work in the Metropolitan Washington Region

Some Preliminary Results from the 2000 Census

#### **Summary of Findings**

- Overall, more than 2.5 million workers now work in the metropolitan Washington region. This is an increase of 170,000 workers since 1990. While significant, this increase was only about a third of the 600,000 worker increase experienced in the 1980 to 1990 time period.
- The greatest growth in new workers was seen at job sites located in the Beltway jurisdictions of Fairfax (+98,000) and Montgomery County (+29,000) in the inner suburbs; and in Loudoun (+39,000) and Prince William Counties (+16,000) and Frederick County, MD (+21,000) in the outer suburbs.
- The core jurisdictions of DC, Arlington County and the City of Alexandria collectively lost more than 60,000 jobs and 30,000 resident workers between 1990 and 2000. It appears from the 2000 Census that most of this job loss occurred in the federal sector of the region's economy. The region had 40,000 fewer federal civilian employees and 18,000 fewer military personnel in 2000 than in 1990. The District also had 12,000 fewer local government employees than in 1990.
- The number of workers living in Prince George's County also declined during the last decade. This 17,500 decrease in the number of workers living in the County also appeared to be related to the 1990 to 2000 drop in the number of federal employees in the region. In 2000, 13,000 fewer federal civilian employees and 4,000 fewer military personnel lived in Prince George's County compared to 1990. Despite the 4% drop in the number of workers living in the County, the number of workers commuting to jobs in Prince George's County remained steady between 1990 and 2000.
- While about 9 out 10 jobs in the metropolitan Washington region are filled by workers who also live in the region, the region now draws in a little more than 10% of its needed workers (about 268,000 in-commuters) from areas outside the metropolitan region. This figure represents an increase of almost 45,000 in-commuters since 1990.
- Within the metropolitan region, the biggest commuting increase since 1990 was seen in Northern Virginia with the addition of 170,000 more workers at employment sites there. The Maryland suburbs saw an increase of 60,000 new workers at their job sites. These increases in workers at Northern Virginia and Maryland suburban sites were offset by a 60,000 decline in the number of workers employed at DC employment sites.
- Workers commuting in Single Occupancy Vehicles (SOV) increased by 14% between 1990 and 2000, while the number of carpool and transit commuters dropped by 10% and 6% respectively. This increase in SOV commuting and the decreases in commuting by carpool and transit also appear to be related to shifts in commuting patterns since 1990. Percent transit use and carpooling to employment sites located in core area jurisdictions is typically 3 to 5 times greater than to employment sites located in the inner and outer suburbs. Conversely, the share of commuting trips to suburban employment centers by SOV is generally much higher. Because the number of workers at core area employment area sites declined, while the number of workers employed at suburban employment centers increased between 1990 and 2000, this shift in commuting destinations alone explains much of the Census reported changes in regional SOV, carpool and transit commuting.
