RESOLUTION ON AMENDMENTS TO THE FY 2007- 2012 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) THAT ARE EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT TO FUND THE 9TH STREET BRIDGE REPAIR PROJECT AND TO MODIFY THE FUNDING OF THE 11TH STREET BRIDGE REPLACEMENT AND RECONFIGURATION PROJECT, AS REQUESTED BY THE DISTRICT OF COLUMBIA DEPARTMENT OF TRANSPORTATION (DDOT)

WHEREAS, the National Capital Region Transportation Planning Board (TPB), which is the metropolitan planning organization (MPO) for the Washington Region, has the responsibility under the provisions of Safe, Accountable, Flexible, and Efficient Transportation Equity Act - A Legacy for Users (SAFETEA-LU) for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the Metropolitan Area; and

WHEREAS, on October 20, 2006 the TPB adopted the 2006 CLRP and the FY 2007-2012 TIP; and

WHEREAS, in the attached letter of June 19, 2007, DDOT has requested amendments to the FY 2007-2012 TIP to add \$7 million in construction funds for the 9th Street Bridge SW over I-395 repair project and to remove \$7 million in construction funds from the 11th Street Bridge SE replacement and reconfiguration project, as described in the attached materials; and

WHEREAS, these project are exempt from the air quality conformity requirement, as defined in Environmental Protection Agency (EPA) regulations "40 CFR Parts 51 and 93 Transportation Conformity Rule Amendments: Flexibility and Streamlining; Final Rule," issued in the May 6, 2005, *Federal Register*;

NOW, THEREFORE, BE IT RESOLVED THAT the National Capital Region Transportation Planning Board amends the FY 2007-2012 TIP to add \$7 million in construction funds for the 9th Street Bridge SW over I-395 repair project and to remove \$7 million in construction funds from the 11th Street Bridge SE replacement and reconfiguration project, as described in the attached materials.

Dear Chairperson Hudgins:

The District Department of Transportation (DDOT) requests that the FY 2007-2012 Transportation Improvement Program (TIP) be amended to include funding for a project to repair the 9th Street Bridge, SW and to remove equivalent funding from another project. A copy of the TIP Project Description Form for the 9th Street Bridge, SW project is attached.

The 9th Street Bridge, SW repair project was included in the FY 2004-2009 TIP, a conforming TIP that was approved by the TPB on 12/17/03. (See FY04-FY09 TIP, project 20 on page 22.) Furthermore, as a repair of an existing bridge, it does not add capacity and therefore should have no negative air quality impacts.

Although the FY 2004-2009 TIP allocated \$7 million for project construction, those funds were subsequently removed from the TIP. DDOT is now ready to obligate \$7 million for project construction. However, to do so, DDOT must reestablish project funding in the FY 2007 portion of the FY07-FY12 TIP. Additionally, DDOT must remove an equivalent amount of obligations from one or more other projects to maintain the fiscal constraint of the TIP. The following project will not be ready to obligate its construction funds in FY07 as originally planned:

 TIP Project # 13 (FY 2007 – FY 20012 TIP, page 39): 11th Street Bridges SE Replacement and Reconfiguration. DDOT's TIP amendment seeks to remove \$7,000,000 in construction funds from this project in FY07.

At a June 5, 2007 meeting with the Virginia Department of Transportation (VDOT), Maryland Department of Transportation (MDOT), Metropolitan Washington Council of Governments (COG), and Federal Highway Administration staff, we became aware that FHWA will not approve any CLRP and TIP amendments after July 1, 2007 that do not comply with all of the SAFETEA-LU planning regulations published February 14, 2007. If this amendment is not approved in June, this project cannot move forward until after TPB actions on the 2007 CLRP scheduled for December, which would delay construction until next spring.

This project was part of a conforming TIP. It is not adding additional capacity. The funding source has been identified, and the TIP will remain fiscally constrained. Therefore, DDOT recommends that the TPB approve this amendment at its June 20, 2007 meeting. We appreciate your cooperation in this matter.
